Description	The capacity development technical assistance (TA) will support the implementation of the government's KALAHI_CIDSS National Community-Driven Development Project (KC-NCDDP). The NCDDP is the government's flagship program, which aims to improve access to basic services, re poverty, and support the recovery and rehabilitation efforts in communities affected by Typhoon Yolanda (international name: Haiyan).	
Project Rationale and Linkage to Country/Regional Strategy	The TA will support the capacity building and institutional support component of the KC-NCDDP, particularly within the context of using the community-driven development approach in responding the post-disaster needs of communities. In coordination with other development partners, the TA assist DSWD in managing the needed capacity building interventions that (i) emphasize needs-bat training programs; (ii) respond to program management needs; (iii) develop and sustain institution capacity for planning and management of training programs; and (iv) strengthen national and subnational capacity to promote, monitor, assist, and evaluate decentralized training programs. In aftermath of Typhoon Yolanda, the TA will help build and deepen capacities further for timely implementation of not only ADB supported activities, but also those of other development partner addition, the TA will help identify ARMM's capacity development needs for future rollout of the KC NCDDP. Status of Implementation Progress (Outputs, Activities, and Issues) 1. Learning and development (L&D) framework established

The TA supports ongoing engagement with the EA's key program staff to enhance the learning and development (L&D) framework. The enhanced framework will provide strategic direction for developing the required competencies of program staff and stakeholders to support KC-NCDDP implementation until 2019. Ongoing activities include a review of DSWD competency model and validation of competencies of key program staff (area coordinators and sub-regional program coordinators).

A competency survey was conducted in November 2016 to determine competency gaps that can be addressed by learning interventions. The survey results are currently under review.

2. Curriculum design and learning modules completed

The TA has prepared training modules and materials on community-based procurement, community finance, safeguards, and M&E which will be used by area coordinating teams to train community volunteers to prepare them for succeeding implementation cycles of KC-NCDDP. Learning modules on participatory local governance, including guidance notes on barangay development planning, are being finalized.

3. Institutional support systems established

The TA is supporting the establishment of an e-learning system which includes digitization and deployment of project manuals through mobile devices, and online query functions. The system will be rolled out by Q2 2017.
