## Trimmu-Panjnad Barrages Improvement Project (TPBIP)

### 1. BACKGROUND

The Government of Punjab is intended to improve and rehabilitate the barrages through Punjab Irrigation Department with the financial assistance of Asian Development Bank (ADB). The main objective of the rehabilitation and upgrading program is to enhance the water supply for sustainable irrigated agriculture. The TPBIP is the part of this rehabilitation and up-dation program. Apart from other project tasks, the rehabilitation of the barrage involved the land acquisition and resettlement impact of the project. Hence, a Land Acquisition and Resettlement Plan (LARP) was prepared by the Project Management Office (PMO) and approved by the ADB, 2014.

### 2. RESETTLEMENT IMPACTS

The construction work is limited to Government owned land and no impact was reported on the private land. In term of resettlement impact, there were total 112 households, impacted through structure, crop, small businesses and trees. In addition, one community structure (Mosque) is also impacted. These included affectees of 62 household's structures, 09 APs were small business operators/fish sellers etc., 12 APs were agriculturists and remaining 29 affectees were involved in fishing occupation (boatmen). Except fishermen and small business operators, other APs are under project impacts permanently.

### 3. STATUS OF LARP IMPLEMENTATION

#### 3.1 Compensation to the Affected Persons

The LARP is being implemented successfully as per ADB's Safeguard Policy Statement (SPS) 2009 and National Laws. The compensation payment is going on right track, as 93 percent of the total affected households have been compensated till the end of September 2016. The compensation was paid in two phases mentioned as below:

Phase-I Compensation paid to 35 APs in June 2016.

Phase-II Compensation paid to 70 APs in July 2016.

Thus total 105 APs have been received compensation. The details of the APs is provided in Annexure-I and Photographs are shown in Annexure-II.

#### 3.2 Unpaid Compensation Cases

Now there are 07 Affected Persons, who are not yet paid. Six are females (Widows), they have to provide succession letter from the court, because their husbands are died and the 7th AP has also died in April 2016 and waiting for his legal inherent papers. These APs are as follow:

The above mentioned cases are under process and will be finalized shortly.

### 3.3 Relocation of Affected Persons (APs)

Before payment of compensation to the APs, there was a concern that after receiving compensation, the APs may take long time to vacate the site. The Project Authority had opinion that some APs may refuse to vacate the site with unexpected new demand causing delay to start the project activities. But due to close coordination, fair measurements of their affected structures, frequent meetings and consultation with them and timely payment to arrange alternate place, the site eviction process completed very shortly and smoothly without any issue. At the end of September 2016, 100 percent APs were moved from the project site and were busy in new construction of their houses. They are relocating near by the project area as they desired to intact with their businesses and relationship with the other peoples and communities in the surroundings.

## 4. ACTIVITIES CARRIED OUT DURING THE MONTH OF JULY 2016

### 4.1 Compensation Paid to APs

During the month of July 2016, for the clearance of working area for the Contractor, in 2nd phase, compensation to 70 Affected Persons (APs) was paid on July 20,2016. The APs were well informed in advance be present at site. The compensation cheques were handed over to the APs at Trimmu Canal Rest house in the presence of displaced persons "Disbursement Monitoring Committee".100 percent compensation amount was paid in one installment to the APs to manage and arrange reconstruction of their houses smoothly and without any delay.

The Cheques were handed over through Malik Pervaiz Arif, Director Environment and Social, PMO Barrages. (Photos attached as Annexure-II).

During the distribution of the compensation cheques to the APs, notices were also served to vacate the site within given period of time. Out of total 112 APs, 105 APs have been compensated (in June 35 APs and July 70 APs).

## 4.2 Removal of Residential/Commercial Structures

Except one community structure (Mosque), all other residential structures have been removed and site is cleared and available for the Project execution. The quarterly data of displacement of Affected Persons (APs) is provided in the following Table.1

## 5. ACTIVITIES CARRIED OUT DURING THE MONTH OF AUGUST 2016

### 5.1 Removal of Residential Structures

All APs (affected of residential structures) have been moved from the site. The APs shifted their salvage material to the new sites to re-use to reduce their construction cost.

### 5.2 Relocation and Reconstruction of Residential Structures of APs

#### 5.2.1 Relocation of APs

They made arrangements to the new location at different places for permanent settlement. The details of the APs losing structures and their relocation places is provided in the Annexure-III. While the agriculturists (squatters) moved to their native villages/basties.



### **5.2.2 Safeguard of the APs**

It was noticed that APs intended to relocate near the batching plant installed by the Contractor. The information regarding safeguard and relocation were discussed with the APs. However, they were given awareness that reside within prohibited area is too hazard for their health particular children, women and elders. Even the plant emission is injurious for their livestock. Then with the guidance of the Consultant engineer, Safeguard Specialist, Contractor's Construction Manager and Director/Deputy Director ESU, PMO Barrages, area was marked to restrain the APs. To make it sure and for the satisfaction of the Project staff, the Chairman of the Committee of affected persons along with other notable APs gave in writing to follow the project requirements. The scanned copies of their undertaking is also attached as Annexure-IV.

### **5.2.3 Relocation of Commercial Structures**

As far as commercial structures are concerned, all have been shifted on main Jhang road about one kilometer away from the existing place. They have established their selling points with the improved condition for more attraction of the customers. A few snaps of their relocation of business structures/points are shown in Annexure-V.

### **5.2.4 Relocation of Community Mosque**

The community structure of Mosque still exists at site. A consultation was arranged at site to relocate the Mosque. The community members included members of affected committee participated in the consultation, while the officials of PMO and NESPAK were also present in the consultation. The relocation of Mosque was discussed in the meeting. The Chairmen of the Committee of the affected persons donated a piece of 10 marlas land for the mosque. All the participants unanimously agreed on the site (place) for Mosque. It was agreed by the donor that the said land will be transferred in the name of Mosque in the Revenue record and at present, he will provide affidavit declaring to donate that piece of land for the community Mosque. The list of participants is provided in the Annexure-VI. It was agreed that a statement will be obtained from a certified religious person (Maulana) to dismantle the existing mosque and to shift on another place. The design will be made and current construction estimate will be made to reconstruct a wide and spacious mosque. For this purpose, a committee has been constituted comprising Imam Masjid of the previous mosque, Sub Divisional Officer (SDO) of Trimmu Barrage, irrigation department and AP to open bank account. The bank account is opened and case is prepared to submit for the approval.

## **6. CONSULTATION AND DISCLOSURE**

### **6.1 Consultation before Displacement**

Consultation is a continues process and play important role to complete the project environmental friendly and socially acceptable. Displacement of the affected persons on permanent basis was a very sensitive matter, which was handled very carefully and professionally by creating rapport and confidence in the APs. They were updated all the time and prepared them mentally and physically to move from the site. For this purpose, regular Consultations were conducted to develop awareness and to support them in planning of shifting etc. All the APs were told about their compensation amount so that they could arrange alternate land and other construction material. They were updated to select new relocation site keeping in view the relocation requirements.



## **6.2 Consultation after Displacement**

The APs were well prepared to move and they were waiting for compensation, As they were paid, they started to dismantle their structures without any delay. It was the outcome of regular meetings and consultations with the APs. Due to doubt free mind, the APs vacated the site within given period of time. The project social and environment staff remained intact with all APs during transition and still attached for their safeguards. Few APs tried to resettle near the Contractor's camp and batching plant and they were made understand not to do so due to hazard effects on their families and livestock as well.

## **7. APPLICATION OF APS FOR EMPLOYMENT**

A contract clause 6.1 "Particular Condition of the Contract" supports the APs that the Contractor will hire APs skilled, preferably unskilled laborers from the affected community. For this purpose, APs were explained the criteria to apply through the ESU-PMO Barrages and Consultants, Sociologists. Total 45 applications included APs themselves and their sons of 18 years and above. These applications were verified from the LARP document that there is no false case. Police verification of the applicants have also been carried out due to security reason. After compiling the data, these applications were also submitted to the Client for further processes. On commencement of work of Contractor, he will accommodate these applicants in different jobs keeping in view their age, health and education. The follow up is made by the PMO to ensure the implementation. The list of APs was sent again to the ESO-PMO to expedite the process and to push the Contractor to provide the jobs, because now the Project construction activities have been started. The list of applicants is shown in the Annexure-VII.

## **8. ACTIVITIES CARRIED OUT DURING THE MONTH OF SEPTEMBER 2016**

### **8.1 Social Framework Agreement (SFA)**

Discussion was held with the Deputy Director, PMO and Environmentalist, Consultants on formation of Social Framework Agreement (SFA). It was decided that three villages/settlements near to Project area will be selected. Five persons from each village/settlement will be enlisted to elect a Chairman, who will be responsible to look after the situation regarding safeguards of the surroundings and to support the project.

In September, after discussion with APs, it was decided to select four settlements/basties to nominate more persons in the SFA to make it more sustainable and effective. The final nomination is in the process with the Director ESU,PMO to notify the SFA.

## **9. SOCIAL COMPLAINT REGISTER (SCR)**

Grievance redress is the prime aspect of safeguard policy. During the field visit, it was decided to place SCR at site to register complaint of the affected persons. A draft format was designed. It was also decided to put this complaint register near the dispensary established by the Contractor for easy access of the complainants. During the field visit, the SCR was checked and discussed, how to enter the complaint, demand and request in the register and how to resolve these entries separately. However, a request from a person (not AP) was received in September requesting for a job as security guard on the project, and he has been appointed on the project.

## **10. GRIEVANCE REDRESS COMMITTEE (GRC)**

Meeting was held at site to form GRC to resolve APs issues. Different nomination of GRC members was considered. The following members of GRC were considered to send to Project Director for notification:

- A representative of PIU preferably Deputy Director, Community Development, PMO.
- A representative of Consultants/Sociologist.
- A member from PID preferably SDO, Trimmu Barrage.
- A representative of Contractor.
- A representative of APs.

The formation of GRC is also at final stage. However, up till end of September 2016, no complaint has been registered from the APs, that indicates, there was no grievance or complaint faced by the APs.

## **11. CONCLUSIONS**

The implementation of the LARP is being carried out by the Client and Consultant and consequently progressing satisfactorily. PMO and Consultants have made all necessary good faith efforts to make disbursement of compensation to the entitled APs. The report confirms that no issue or any payment related encumbrance found in the Project.
