Project Rationale and Linkage to Country/Regional Strategy

Evaluation is an important part of ADB's project cycle. Evaluation of ADB operations comprises two parts: (i) self-evaluation by the operations departments responsible for preparing and implementing projects, programs, and TA operations leading to a completion report; and (ii) independent evaluation by IED through the preparation of project and cluster TA performance evaluation reports. IED also validates a statistically significant sample of project completion reports (PCRs) through validation reports.

A PCR is prepared by processing department for all completed projects and TAs (except TAs resulting in a loan) usually 12_24 months after project completion. The main objective of a PCR is to learn from the experiences of borrowers, executing agencies, and ADB in implementing projects, and to use the lessons to improve the performance of ongoing and future ADB-financed projects. The PCRs ratings are used as a measure of ADB's development effectiveness and as inputs to country partnership strategy formulations.

IED's guidelines on project performance evaluation report (PPER) preparation defines the performance rating categories and rating criteria and PCR preparation follows these guidelines. Executing agencies also prepare their own PCRs, which serve as an input to ADB's PCR. ADB staff also guide executing agencies in preparing their PCRs by providing general guidance and requirements, including the contents of the PCRs. However, a review of selected government PCRs indicates that these vary significantly in quality, contents, analysis, and preparation. This often becomes challenging to the ADB staff responsible for PCR preparation. The training aims to address these concerns

The main output of the S-CDTA will be workshop to train executing and implementing agency staff in preparing quality PCRs. As stated above, the training is expected to equip staff in better understanding of evaluation principles, link between M&E, and sound understanding ADB's guidelines in preparing PCRs. Another key output will be PPER guidelines translated in national language to promote better understanding of the guidelines by executing and implementing agency staff. The expected impact of the proposed small scale capacity development TA (S-CDTA) will be more transparent and better result analysis, demonstrated by good quality PCRs validated by IED. The expected TA outcomes will be enhanced self-evaluation capacity of executing and implementing agency staff, timely submission of good quality PCRs by executing agencies to ADB, and identification of relevant lessons from project implementation. The training will help executing and implementing agencies to also institutionalize evaluation culture in their own agencies.
