PROJECT PREPARATORY TECHNICAL ASSISTANCE

A. Justification

1. The proposed Qingdao Smart Low-Carbon District Energy Project was discussed in the country programming mission held in Manila on October 2013 as firm 2015. At that time, Asian Development Bank (ADB) received only a brief project description which does not contain sufficient information to conduct the project appraisal immediately. A project preparatory technical assistance (PPTA) is required to (i) conduct the due diligence on several aspects of the proposed loan (para. 9, main text), (ii) familiarize the implementing agency with ADB's procurement procedure, disbursement procedure, and environment and social safeguards requirement, and (iii) facilitate learning opportunities in emerging district energy technologies and business practices. The project team and consultants supported by the implementing agency will work up-front with the local design institute to synchronize ADB's safeguard requirements into the domestic requirements.

C. Cost Estimate and Proposed Financing Arrangement

3. The TA is estimated to cost \$700,000 equivalent, of which \$600,000 equivalent will be financed on a grant basis from ADB's Technical Assistance Special Fund (TA special fund-other

sources). The Government will provide the balance for local costs to cover in-kind counterpart costs and services including counterpart staff, office space, furniture, administrative support services, and local city transport and logistics costs. The detailed cost estimate is in Table A5.2. The government was advised that approval of the TA does not commit ADB to financing any ensuing project.

Purpose

D. Consulting Services

4. The TA will take a two stage approach to use consulting services efficiently. Part 1 (data gathering and preliminary assessment) will require a total of 7.5 person-months of one international and three individual national consultants while Part 2 (detailed assessment) will require a total of 6 person-months of international and 15 person-months of national consulting services through a consulting firm. Part 1 will be implemented while the selection of consulting services of Part 2 is underway. Hiring a small number of individual consultants is more appropriate for the quick mobilization of consulting service and cost-effective than firms to perform the assignment of Part 1. The information collected by the consultants of Part 1 will be carried over to the consultants of Part 2. The expected benefit of this approach may advance the loan processing schedule. The required positions and person-months are indicated in Table A5.3. As for Part 1, the three individual national consultants will be engaged by ADB in accordance with the Guidelines on the Use of Consultants (2013, as amended from time to time). As for Part 2, a consulting firm will be recruited by ADB in accordance with ADB's Guidelines on the Use of Consultants through quality- and cost-based selection method (with a guality-cost ratio of 90:10 due to importance of technical aspects) using simplified technical proposal. The procurement of equipment by consultants, under the TA, will follow ADB's Procurement Guidelines (2013, as amended from time to time). The proceeds of the TA will be disbursed in line with ADB's Technical Assistance Disbursement Handbook (2010, as amended from time to time). The equipment procured under the TA will be turned over to the executing agency upon TA completion.
