Summary of Environmental and Social Aspects

Environmental Aspects

URS was appointed to undertake the ESIA in November 2013 to comply with EBRD requirements. The main environmental issues are air quality, water and wastewater quality, noise and vibration level, marine and terrestrial biodiversity (flora and fauna), hazardous and non-hazardous wastes generation and occupational health and safety within the project's area of influence from gas condensate field development, construction works and operation of project facilities including associated infrastructure facilities.

Involuntary Resettlement	The State Oil Company of Azerbaijan Republic (SOCAR) is responsible for land acquisition in connection with the project. The due diligence of the land acquisition process will confirm whether the actions are in accordance with EBRD"s and ADB"s safeguard principles and policy requirements. The Environmental and Social Compliance Audit report shall identify corrective actions, measures and recommendations to address the gaps identified, to comply with the Safeguard Requirements on Involuntary Resettlement.
Indigenous Peoples	The ESIA confirms that there are no indigenous communities in the project locations that will be impacted.
Stakeholder Communication, Participation, and Consultation	The audit will review the stakeholder engagement process adopted and propose corrective actions, as required, to ensure compliance with ADB requirements.
