I. INTRODUCTION

1. The Kyrgyz Republic became a member of the Eurasian Economic Union (EEU) on 12 August 2015.¹ The country's accession to the EEU is expected to have diverse and significant implications for the country's economy. With the EEU's combined population of about 180 million and its larger market, the intended free movement of goods, services, capital, and labor, and elimination of customs controls and nontrade barriers, the EEU presents significant economic opportunities to the Kyrgyz Republic. The Kyrgyz Republic's economic policies, regulations, and the legal framework need to be adjusted to those of the EEU, and the potential economic and social costs of the accession need to be minimized. It is in this context that the Government of the Kyrgyz Republic has requested the Asian Development Bank (ADB) to provide the proposed technical assistance (TA),² which was included into the country operations business plan, 2015–2017.³

2. Consultations with representatives of the government, the country's private sector and think tanks, and development partners took place during the reconnaissance and fact-finding phases of TA preparation.⁴ The government expressed its concurrence with the TA design as described in the August 2015 fact-finding mission's memorandum of understanding. The design and monitoring framework of the TA is in Appendix 1.

II. ISSUES

3. Excluding the small island states, the Kyrgyz Republic is one of ADB's smallest developing member countries in terms of land area, population, and size of the economy. The country's real gross domestic product (GDP) is extremely volatile, reflecting significant dependency on several factors and vulnerability to external shocks.⁵ The country has strong economic ties with the Russian Federation, through remittances of the Kyrgyz workers, currency movements, trade, and investment channels.⁶

4. The Kyrgyz Republic's accession to the EEU occurs in the challenging internal and external economic environment, including economic slowdowns in the Russian Federation and in Kazakhstan.⁷ Both developments exert a downward pressure on the Kyrgyz economy, largely through the remittances and trade channels. Remittances started to fall 22.5% in the last quarter

of 2014, and declined by more than 25% in the first half of 2015 (year-on-year). The sharp depreciation of the Russian ruble and the devaluation of the Kazakh tenge have put pressure on the som, which depreciated against the US dollar by 20% in 2014, and by 14.5% since the beginning of this year, resulting in higher inflation. Together with the lower expected gold production in 2015, the Kyrgyz Republic's real GDP growth is forecast to fall to 1.7%, down from 3.6% in 2014.⁸

5. The undiversified economy, driven mainly by gold production and remittances-backed private consumption, limits economic opportunities at home and leads to high unemployment. Given the country's limited economies of scale and significant economic vulnerabilities, regional economic integration is essential for the Kyrgyz Republic's economic prospects and its people's livelihoods.

6. The Kyrgyz Republic's accession to the EEU will impact the country's economy via the trade, migration, and investment channels.⁹ For the Kyrgyz Republic, the key issues include the elimination of customs controls at intra-EEU borders, an increase in duties on imports from outside the EEU, the adoption of the EEU technical regulations and standards, and the supply response from the specific sectors of the Kyrgyz economy, in particular, agriculture and food processing, garment, and the re-export sector.¹⁰ In addition, the Kyrgyz Republic's commitments and obligations under the World Trade Organization, of which the country is a member since 1998, would need to be reconsidered in light of the EEU membership.

7. The recurrent theme in the discussions with key stakeholders during the preparation of the proposed TA was the ensuing uncertainty as to the implications of the country's accession to the EEU. The following emerged as key issues related to the country's accession to the EEU: (i) the economic opportunities and risks to the country's economy; (ii) the considerable challenges during this transition period; (iii) the central and local government agencies' weak capacities related to the accession to the EEU; and (iv) the need for better and wider public awareness of the issues pertaining to the accession to the EEU, especially among the country's business sector.

III. THE POLICY AND ADVISORY TECHNICAL ASSISTANCE

A. Impact and Outcome

8. The proposed TA will support the Kyrgyz Republic following its accession to the EEU, with the view of capturing the economic opportunities presented by the EEU's larger market and its free movement of goods, services, capital, and labor, and minimizing the potential economic and social costs of the accession. The impact of the proposed TA will be the improved prospects of the Kyrgyz Republic's economy within the framework of the EEU. The outcome of the TA will be the improved capacity and capability of the Kyrgyz Republic's government to

formulate and adopt sound economic and social policies pertinent to the country's accession to the EEU.¹¹

B. Methodology and Key Activities

9. The above outcome of the TA will be achieved through the following outputs and activities.

10. **Output 1: Policy advice and analytical support on the Eurasian Economic Union accession issues.** These will include policy advice and analytical support for the Kyrgyz Republic's government on strategic issues, to ensure that the Eurasian Economic Commission's decisions do not have a detrimental effect, and are in the interests of the country's development. Specific issues for analytical and monitoring support include macroeconomic impacts, adoption of the common external tariff of the EEU, impact on trade, labor and investments, coordination on specific technical regulations, and impact on selected sectors of the economy.¹²

11. **Output 2: Improved methodology, coverage, and collection of statistical data to monitor the impact of the country's accession to the Eurasian Economic Union.** The Kyrgyz Republic's national statistics have limited methodology, scope, and coverage, severely hindering a routine monitoring of economic developments.¹³ This component will focus on improving the methodology, coverage, and collection of data on "mutual trade" in the Kyrgyz Republic, compatible and "mirror" trade statistics with EEU member countries, better statistics on labor migration and remittances, and other indicators required for the meaningful monitoring of the impact of the Kyrgyz Republic's accession to the EEU.¹⁴

12. **Output 3: Tailored training and public awareness programs to capture the economic opportunities presented by the Eurasian Economic Union.** To address the dearth of information on changes in economic policies, regulations, technical standards, legislative documents, etc., both among the public and private sectors, which hinders their adaptation to the new realities of the economy, this component will focus on training and public awareness programs specifically tailored for key stakeholders: central and local governments, small and medium-sized enterprises, individual entrepreneurs, business associations, and the country's think tanks.¹⁵

13. The following key risks to the TA project's implementation need to be considered: (i) political instability that can derail the initiated economic reforms; (ii) the weak voice of the Kyrgyz Republic in the supranational bodies of the EEU, which is dominated by larger EEU

member countries; and (iii) frequent turnover of government staff that may result in ineffective use of policy advice and recommendations.

C. Cost and Financing

14. The TA is estimated to cost \$600,000, of which \$500,000 will be financed on a grant basis by ADB's Technical Assistance Special Fund (TASF-V). The government will provide counterpart support in the form of counterpart staff, office space and supplies, and other in-kind contributions. The Ministry of Economy (MOE) and other relevant government agencies and departments will provide the required materials, information, and data. The cost estimates and financing plan are in Appendix 2.

D. Implementation Arrangements

15. The MOE is the state agency responsible for the overall coordination of the Kyrgyz Republic's accession matters, and it will be the executing agency for the TA. The TA will be administered by ADB. Several MOE departments and divisions will be involved in the TA, including the Department on Accession to the EEU and the World Trade Organization Issues, the Department of Technical Regulations and Metrology, the Macroeconomic Department, the Department of Strategic Planning and Regional Development, and the Department of EEU accession) to support and coordinate all TA activities, and to assist with absorption of the TA outcomes into the MOE's work and activities.

16. A TA steering committee will be established under the chairmanship of the minister of economy, and will comprise senior government officials from the executing agency, the Government Staff Department, Ministry of Finance, National Statistical Committee of the Kyrgyz Republic, and other relevant agencies. The steering committee will oversee TA implementation and recommend adjustments to the TA scope, if needed. During the TA implementation, the MOE will coordinate activities of all relevant stakeholders, including the central and local authorities involved in the project, as well as the activities of other development partners in this area.

17. The TA will be implemented over 24 months, from January 2016 until December 2017. The TA will engage 12 person-months of international and 32 person-months of national consulting services in the field of macroeconomics, international trade and regional economic integration, statistics, and others. The outline terms of reference for the consulting services is in Appendix 3. The consultants will be engaged on an individual basis,¹⁶ and a national consulting firm will be engaged to implement the training and public awareness component. Resource persons (to be engaged for round tables, seminars, and study tours) will be recruited from ADB member countries using the single-source selection method. All consultants will be recruited in accordance with ADB's Guidelines on the Use of Consultants (2013, as amended from time to time). All procurement of goods will be conducted in accordance with ADB's Procurement Guidelines (2015, as amended from time to time). The equipment will be used for implementation of the TA and will be transferred to the executing agency at TA completion. All disbursement under the TA will be carried out in accordance with ADB's *Technical Assistance Disbursement Handbook* (2010, as amended from time to time).

18. A series of round table discussions and workshops will be held under the TA, with participation of external experts, analytical organizations, development partners, and other relevant stakeholders. An evaluation of the TA outputs and outcomes will be carried out at the end of the TA and reflected in the TA completion report.

19. The TA will be monitored through biannual review of the TA implementation, involving submissions of progress reports by the consultants, and consultations with the government during TA review missions.

IV. THE PRESIDENT'S DECISION

20. The President, acting under the authority delegated by the Board, has approved the provision of technical assistance not exceeding the equivalent of \$500,000 on a grant basis to the Government of the Kyrgyz Republic for Accession to the Eurasian Economic Union—Capturing the Opportunities and Addressing the Risks, and hereby reports this action to the Board.

OUTLINE TERMS OF REFERENCE FOR CONSULTANTS

1. The technical assistance (TA) will engage 12 person-months of international and 32 person-months of national consulting services in the field of macroeconomics, international trade and regional economic integration, statistics, and others. All consultants will be recruited in accordance with the Asian Development Bank (ADB) Guidelines on the Use of Consultants (2013, as amended from time to time).

A. International Consultants

2. **Macroeconomist and team leader** (6 person-months, intermittent). The team leader will lead the international and national specialists and be responsible for all TA outputs. The team leader will be a macroeconomist with preferably 15 years of international experience, including in economic development and regional integration affairs. A working knowledge of Russian language and work in the former Soviet Union countries would be desirable. The team leader will be responsible for preparation and submission of all TA progress reports and documentation.

3. To maximize the opportunities offered to the Kyrgyz Republic by the membership in the Eurasian Economic Union (EEU), and to alleviate potential costs and risks during the transition period associated with accession to the EEU, the macroeconomist, in collaboration with other consultants, will provide support and advice to government agencies on the following issues:

- development of methodology for analyzing the impact of the Kyrgyz Republic's accession to the EEU on the selected sectors of the economy (including agriculture and food processing, textile industry, construction materials production, trade, construction, and others); support in carrying out a pilot analysis of one of the sectors chosen by agreement with the Ministry of Economy (MOE);
- (ii) methodological support in establishing a system of regulatory impact analysis of regulations and policies of the Eurasian Economic Commission (EEC) and other bodies of the EEU on the Kyrgyz economy, development of principles and rules for determining the priority directions for the analysis of the regulatory impact analysis of acts and decisions of the EEU, undertaking a pilot regulatory impact analysis of the most significant decisions, and training of MOE staff and other relevant agencies in such an analysis (together with the international consultant on international trade and regional integration and national consultants on macroeconomics, legal, and social issues);
- (iii) methodological support in the adaptation of the system of macroeconomic and budgetary forecasting to procedural interaction with the EEC (e.g., using consensus forecast of oil prices, global economic growth, imports, and other exogenous variables, modification of the method of budgetary forecasting);
- (iv) development of opportunities for exchange of experiences between relevant staff of the Kyrgyz Republic government and their colleagues from other EEU member states working in the field of macroeconomic management, statistics, tax administration and other fields (together with an expert on statistics and other members of the group); and
- (v) organization of expert discussions, round tables, and other types of professional and public debate to discuss and disseminate the analytical products of the TA (together with other members of the group).

4. **Economist on international trade and regional integration** (3 person-months, intermittent). The consultant will preferably have at least 15 years of international experience, including in international trade, economic development, World Trade Organization issues, and regional integration. A working knowledge of Russian language and work in the former Soviet Union countries would be desirable. The consultant will support the government on the following issues (in addition to those mentioned in the tasks of the macroeconomist above):

- (i) development of methodology for the analysis of the common external tariff of the EEU and its dynamics;
- development of methodology for analyzing the impact of changes in domestic economic policies in the Russian Federation, Kazakhstan, and other countries of the EEU, on the Kyrgyz economy (e.g., impact of the Russian import substitution policy or Kazakhstan's policy of intensive agriculture development on the Kyrgyz export to these countries);
- (iii) analytical support for issues of nontariff regulation (veterinary, sanitary and phytosanitary, and technical types of control), e.g., development of recommendations—on the basis of cost–benefit and institutional analyses—on introduction of new laboratories, certification procedures, and of adaptation of businesses to the new or modified requirements; and
- (iv) development of methodology for analysis of external shocks that have a direct impact on the EEU members, and through them, on the Kyrgyz Republic (e.g., the fall in global oil prices, western sanctions, etc.).

5. **Statistics expert** (3 person-months, intermittent). The consultant will have at least 10 years of professional experience, including in statistics on international trade and balance of payments, labor migration, and others. A working knowledge of Russian language and work in the former Soviet Union countries would be desirable. The consultant will work closely with other team members in delivering the TA outputs. The consultant will support the government on the following issues (in addition to those mentioned in the tasks of the macroeconomist above):

- (i) methodological support for development and implementation of information and recording system of the Kyrgyz Republic's imports and exports from and to the EEU countries of goods by rail, air, and road transport modes for the State Tax Service, the State Customs Service, and the National Statistical Committee;
- (ii) analysis of the effectiveness or assessment of the ongoing National Statistics Committee's work on "mutual trade" statistics between the Kyrgyz Republic and other EEU members; development of recommendations to improve the system, taking into account all possible sources of data, including the "mirror" statistics; and
- (iii) development of recommendations for improving the labor migration statistics, including the clarification of the conceptual framework (e.g., who constitutes a migrant worker), improving accounting of foreign workers in the country, and exploring possibilities of using the European Union and other regional integration arrangements' experiences in labor movement statistics.

B. National Consultants

6. **Macroeconomist and deputy team leader** (12 person-months, intermittent). The specialist will undertake relevant macroeconomic work, coordinate the work of national consultants, and be responsible for interaction of the consulting team with the government bodies of the Kyrgyz Republic. The consultant will be an expert in macroeconomics with at least

15 years of experience in government and international development projects. The consultant will support the government on the following issues:

- a pilot analysis of the impact of the Kyrgyz Republic's accession to the EEU on one of the sectors of the economy, selected in consultation with MOE (together with the international consultant and macroeconomist);
- (ii) a pilot regulatory impact analysis of most significant acts and decisions of the EEC (economic aspects); development of recommendations on institutional, procedural, and operational issues of regulatory impact analyses of the EEC decisions in the Kyrgyz government; training of relevant MOE and other agencies' staff in such an analysis (together with the international consultant and macroeconomist and national consultants on legal and social issues); and
- (iii) support for the adaptation of the systems of macroeconomic and budgetary forecasting to the interaction procedures with the EEC.

7. **Social and labor market expert** (6 person-months, intermittent). The expert will have at least 10 years of experience in government or international development projects. The consultant will support the government on the following issues:

- (i) a pilot analysis of the impact of the Kyrgyz Republic's accession to the EEU on one of the sectors of the economy selected in consultation with MOE (social aspects), and
- (ii) a pilot regulatory impact analysis of most significant acts and/or decisions of the EEC on social aspects of the Kyrgyz economy.

8. **Legal expert** (6 person-months, intermittent). The expert will have at least 10 years of legal experience in government or international development projects, as well as experience of working on harmonization of the legislation of the Kyrgyz Republic with the legal framework of the EEU. The legal expert should have strong knowledge of the EEU framework, policies, rules and regulations, including those for accession; strong knowledge of the Kyrgyz Republic's policies, laws, rules, and regulations that may be affected by the accession; and experience in accession to, or other similar integration with, regional or other international arrangements similar to the EEU, including on revising legal frameworks, laws, rules and regulations to conform to, adapt to, or accommodate the regional or international arrangements acceded to. The consultant will support the government on the following issues:

- (i) a pilot regulatory impact analysis of most significant acts and/or decisions of the EEC (legal aspects); and
- (ii) an analysis of changes in the investment and business climate of the Kyrgyz Republic in the context of the EEU and development of recommendations for its improvement (together with the international consultant and macroeconomist).

9. **International trade and international regional integration expert** (4 person-months, intermittent). The expert will have at least 10 years of experience in government or international development projects. The consultant will support the government on the following issues:

- (i) development of methodology and analysis tools of the common external tariff and its dynamics;
- (ii) a pilot analysis of the impact of changes in the domestic economic policies of the Russian Federation, Kazakhstan, and other EEU countries on the Kyrgyz economy; and
- (iii) a pilot analysis of external shocks that have a direct impact on the EEU members, and indirect impact on the Kyrgyz Republic.

10. **Statistics expert** (4 person-months, intermittent). The expert will have at least 10 years of experience in government or international development projects. The consultant will support the government on the following issues:

- (i) development and implementation of information system for recording Kyrgyz imports and exports of goods from and to the EEU;
- (ii) assessment and improvement of the statistical system of "mutual trade" with the members with the EEU; and
- (iii) improvement of labor migration and remittances statistics.

11. **Training and public awareness specialists**. A consulting firm will be engaged under an output-based contract, and will work closely with other TA team members, government counterparts, and other stakeholders on coordinating and organizing the training and public awareness programs related to the Kyrgyz Republic's accession to the EEU. The consultant will support the government on the following issues:

- (i) organization of training of (a) entrepreneurs and business associations; (b) government staff; (c) representatives of civil society and media; and (d) other groups as required, on new rules and regulations in the context of the EEU, including on changes in the taxation regime, customs procedures, sanitary and phytosanitary measures, technical regulations, statistics, and others; and
- (ii) public awareness campaign on the conditions and practical implications of the Kyrgyz Republic's accession to the EEU, preparation of relevant television and radio programs, and publication and dissemination of various analytical materials and information.

12. All national consultants will participate in the interagency interaction and cooperation, in line with their main expertise, and in discussions of the analytical products under the TA.

C. Short-term Experts and Resource Persons

13. Short-term experts and/or resource persons will be engaged to prepare presentations and analytical materials on specific topics, and to act as discussants or panelists on related policy issues.
