GLOSSARY

Compensation. Payment in cash or in kind for an asset or a resource that is acquired or affected by a project at the time the asset needs to be replaced.

Cut-off date. The completion date of the census of project-displaced persons is usually considered the cut-off date. A cut-off date is normally established by the borrower government procedures that establishes the eligibility for receiving compensation and resettlement assistance by the project displaced persons. In the absence of such procedures, the borrower/client will establish a cut-off date for eligibility.

Displaced persons. In the context of involuntary resettlement, displaced persons are those who are physically displaced (relocation, loss of residential land, or loss of shelter) and/or economically displaced (loss of land, assets, access to assets, income sources, or means of livelihood) as a result of (i) involuntary acquisition of land, or (ii) involuntary restrictions on land use or on access to legally designated parks and protected areas.

Entitlement. Resettlement entitlements with respect to a particular eligibility category are the sum total of compensation and other forms of assistance provided to displaced persons in the respective eligibility category.

Host communities. Communities receiving physically displaced persons of a project as resettlers.

Income restoration. Re-establishing productive livelihood of the displaced persons to enable income generation equal to or, if possible, better than that earned by the displaced persons before the resettlement.

Meaningful consultation. A process that (i) begins early in the project preparation stage and is carried out on an ongoing basis throughout the project cycle; (ii) provides timely disclosure of relevant and adequate information that is understandable and readily accessible to affected people; (iii) is undertaken in an atmosphere free of intimidation or coercion; (iv) is gender inclusive and responsive, and tailored to the needs of disadvantaged and vulnerable groups; and (v) enables the incorporation of all relevant views of affected people and other stakeholders into decision making, such as project design, mitigation measures, the sharing of development benefits and opportunities, and implementation issues.

Physical displacement. Relocation, loss of residential land, or loss of shelter as a result of (i) involuntary acquisition of land, or (ii) involuntary restrictions on land use or on access to legally designated parks and protected areas.

Replacement Cost. Replacement cost involves replacing an asset at a cost prevailing at the time of its acquisition. This includes fair market value, transaction costs, interest accrued, transitional and restoration costs, and any other applicable payments, if any. Depreciation of assets and structures should not be taken into account for replacement cost. Where there are no active market conditions, replacement cost is equivalent to delivered cost of all building materials, labor cost for construction, and any transaction or relocation costs.

Relocation assistance. Support provided to persons who are physically displaced by a project. Relocation assistance may include transportation, food, shelter, and social services that are provided to the displaced persons during their relocation. It may also include cash allowances that compensate displaced persons for the inconvenience associated with resettlement and defray the expenses of a transition to a new locale, such as moving expenses and lost work days.

Semi Annual Social Monitoring Report

A. Project Introduction and Background

- 1. Government of Jharkhand (GoJ) has embarked upon a comprehensive program to upgrade its road network through the State Highways Authority of Jharkhand (SHAJ). SHAJ. The GoJ with the purpose to enhance capacity and efficiency in improving the state road network has established State Highways Authority of Jharkhand (SHAJ), as an autonomous body in year 2007. The broadest responsibilities include the development, maintenance, and management of any state roads entrusted by the state government.
- 2. As part of this mandate, the Project has been conceptualized to improve state highways connectivity. This Project aims to improve the connectivity to the neglected area by improving the road infrastructure and providing connectivity, which will contribute towards the expansion of economic opportunities, hence reducing the interstate disparities within India. The Project will also result in improved livelihood and trade opportunities for non-urban population.
- 3. The Project will also provide to support in increasing the institutional capacity of the SHAJ as an autonomous road development agency, aiming to ensure long-term sustainable development and maintenance of the state road network in Jharkhand. SHAJ will become the nodal agency for promoting road safety in Jharkhand based on the road safety master plan to be developed under the Project




Figure 1. Location of the roads under the Project

- 4. The project involves rehabilitation/reconstruction and widening of 4 existing roads totalling 176.90 kilometres in length. The SHAJ has prepared Resettlement Plans (RP) for all 04 roads during the processing of the loan with the objective to assist the affected people to improve or at least restore their living standards to the pre-impacted level. The RPs captures the involuntary resettlement impacts arising out of the proposed improvements to the 04 roads spread over 6 districts. The index map giving the location of the different subprojects is presented as Figure 1.

B. Purpose of the Report:

5. The main objective of this monitoring report is to supervise the subproject impacts and to determine whether resettlement goals have been achieved and more importantly whether livelihood and living standard have restored, enhanced and suggesting the suitable recommendations for improvement. This report covers resettlement and social safeguard monitoring results to comply with the spirit of ADB policy to 'enhance stakeholders' trust 'in and ability to engage with ADB, and thereby increase the development impact (of projects) in which disclosure of safeguard monitoring is a prominent aspect.

C. Monitoring Period

5. This consolidated report outlines monitoring implementation of social safeguard activities during inception of the project in March 2016 to December 2016.

D. Social Safeguard Categorisation:

6. The approved social safeguard categories for Loan 3276- IND: Second Jharkhand State Road Project (SJSRP) is "A" for involuntary resettlement (IR); and "C" for Indigenous Peoples (IP). The Safeguard Policy Statement (SPS), 2009 is applicable for the Project.

E. Sub-projects under Loan 3276- IND: Second Jharkhand State Road Project (SJSRP)

7. The said project involves rehabilitation/reconstruction and widening of 4 existing roads totalling 176.90 kilometres in length. The details are provided as below:

F. Institutional Arrangements

- 8. The implementation of RP will be carried out through a set of institutions at various levels including implementation framework, and the organizations involved their roles and responsibilities in the implementation of the plan. The primary R&R institutions in this project would include the following:
 - Executing Agency (EA) will be the State Highways Authority of Jharkhand (SHAJ)
 - EA will be supported by Project Implementation Units (PIU) at the subproject level.
 The PIU will use the services of the following institutions in implementation of the sub components of the project including resettlement actions.
 - Non-Government Organizations (NGO) or R&R Implementation agency

(i) Executing Agency - State Highways Authority of Jharkhand (SHAJ)

9. SHAJ) will be the Executing Agency for this Project. At the state level, SHAJ is headed by Chief Executing Officer (CEO) and a full-time Director reporting to CEO is responsible for day to day implementation of the project. One officer of the rank of Deputy General Manager (DGM) has been tasked with the additional responsibility of all safeguards related activities. The role

of the PMU is policy guidance, coordination and planning, internal monitoring and overall reporting of the RP implementation.

(ii) Project Implementation Unit (PIU)

10 The PIU headed by a Project Manager (DGM) is responsible for the overall execution of subprojects. The Project Manager (DGM) will supported by a safeguard focal point in overall implementation of R&R activities and liaison with district administration for support for land acquisition and implementation of RP. The SHAJ was established three PIUs in Dumka, Dhanbad and Khunti districts.

(iii) Non-Government Organizations (NGOs)

11. The SHAJ has appointed four qualified and experienced NGO to assist in implementation of the RPs of four packages. Three NGOs have been mobilised so far while as NGO for Package 4 is yet to be mobilised. The SHAJ initiated the process of termination of NGO due to non-performance. Details of NGOs is given in Table No.2

G. Land Acquisition & Resettlement Impacts:

12. The project for the construction of 4 road subprojects measuring 176.90 Km requires the acquisition of 73.585 ha of land impacting 4024 affected households (AHs) comprising of 37855 displaced people (DP) spread over 6 districts. The Project also is expected to impact 1814 non-titled holders (NTH) (313 encroachers and 1501 squatters) and 185 common property resources (CPR).

(1) Dumka - Hansdiha Road:

14. The subproject involves reconstruction and widening of the 44 km long road corridor, which connects the Dumka town with Hansdiha. The start point of the corridor is Dumka and reaches Bhagalpur border meeting two districts of Dumka and Godda. The proposed corridor traverses along 31 villages in the districts of Dumka and Godda. At the time of preparation of the RP, the subproject construction envisaged the acquisition of private land measuring 10.30 ha and 350 private structures. The total of 611 households (including 53 tenants and 98 employees) comprising of 4025 DPs are expected to be affected. The subproject will also impact a total of 84 CPRs.

(2) Giridih – Jamua - Sarwan Road:

15. The subproject involves reconstruction and widening of the 45.20 km long road corridor, which connects the Jamua town with Sarwan. The proposed road traverses along 10 villages of the Giridih district. Some of the key villages that proposed road passes through and will incur impact because of the Project are Bilotand, Deopahadi, Dhenga, Gamhardih, Jhalkhirudih, Khamarbad, Kusmabad, Manakdiha, Nekpura and Pathratand. The subproject construction will impact 1942 households (including 50 tenants and 90 employees) comprising of 19,885 DPs.

(3) Gobindpur - Tundi-Giridih Road:

16. The subproject involves reconstruction and widening of the 44 kms long road corridor, which connects the Gobindpur town with the Chatro village. The start point of the corridor is Gobindpur junction at the chainage of 0+000 and ends at the chainage no. 43+550 near the Chatro village. The road is a key artery and is one of the most important roads in the Dhanbad district. The proposed corridor traverses along 21 villages in the districts of Dhanbad and Giridih. The proposed road package will involve acquisition of private land measuring 5.623 ha, thus impacting 820 private structures belonging to 1119 households and 24 CPRs. The 1119 AHs comprise of 11671 DPs including 103 tenants and 70 employees.

(4) Khunti – Tamar Road:

17. The subproject involves reconstruction and widening of the 43.7 km long road corridor, which connects Khunti town and district headquarter with Tamar. The corridor starts at Khunti and ends at Tamar connecting Ranchi–Jamshedpur (NH – 33). The proposed road crossing two districts of Khunti and Ranchi is the lifeline of the people who resides in both district and the only way to connect the two. The road caters not only to traffic from Khunti to Tamar but also to other major places in North & Eastern Jharkhand such as Jamshedpur, Ranchi etc. The proposed corridor traverses along 21 villages in the districts of Khunti and Ranchi. A total of 134 structures involving 352 households (including 3 tenants and 26 employees) and comprising of 2264 DPs will be affected as the result of the Project.

H. Status of Implementation of Resettlement Activities

(i) Cut-off Date

18. The cut-off date for those who have legal titles of their land/assets is the date of notification under The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and for those without titles, the cut-off date is date of completion of census survey.

(ii) Package wise status

a. Dumka - Hansdiha Road

19. Land acquisition under LARR 2013 has been initiated and Sido Kanhu Murmu University, Dumka (Jharkhand) has been given the task of preparation of the social impact assessment (SIA) report. The identification of CPR and non-title holders (NTH) by the NGO has been completed, while identification of titleholders (TH) is in progress. The total number of 96 NTH (one squatters and 95 encroachers) and 43 no CPRs has been identified so far and preparation of micro plans is in process.

b. Giridih – Jamua - Sarwan Road

20. The land acquisition has been initiated and notice to persons interested under section 21 of LARR 2013 has been issued. The process of identification of NTH and CPR with the support of the NGO is under process. So far 92 NTH Squatters 08, Encroacher 67) and 22 no CPRs been identified and the preparation of micro plans is in process. The micro plans are being prepared for the identified DPs

c. Govindpur-Tundi-Giridih Road

21. The identification verification of the affected households is under process. Census of NTH families/people (Squatters, **Encroachers** and CPRs) pertaining proposed ROW by the widening of project stretch is continued. So far **310 NTH (Squatters 50, Encroacher 260)** and CPR **18 have been identified.** Identification of Title holder APs are not started.

22. The subproject would not require the acquisition of land, since the ROW required for construction would be located on government land only, and relevant revenue records are currently being obtained from the Revenue Department. The identification of NTH will be started finalisation of the land acquisition requirement.

I. Capacity Building

23. As part of the capacity building exercise, a training on social safeguards and RP implementation was conducted for the respective PIU officials and NGOs staff. The training session covered following topics (i) ADB's Social Safeguard Requirements; (ii) Resettlement Framework (RF); (iii) Core labour standards; and (iv) Government of India's new law on land acquisition viz. The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

J. Public Consultation and Disclosure

- 24. In order to engage with the community and enhance public understanding on the Project and address the issues pertaining to resettlement, various sections of DPs and other stakeholders were consulted through focus group discussions (FGD), meetings and individual interviews in the during the implementation of the Project (Appendix 3). The informal as well formal consultations were conducted by the NGOs and CSC's Land Acquisition and Resettlement Specialist during at the inception and during the implementation of the project. The opinions of the stakeholders and their perceptions were obtained during these consultations.
- 25. The people were aware about the improvements to the existing road was envisaged but were not well informed about the final alignment and proposed ROW of the project. The APs welcomed the idea of road improvement and requested that compensation should be provided for their loses. The DPs assured full support to the project. The CSC has advised the NGOs to distribute that summary RP translated in Hindi to AHs. The hand-outs should include a summary of the scope of the project, details of cut-off date, details of eligibility and entitlements, the grievance redressal mechanism and contact details of the PIU and the implementing support NGO.

K. Grievance Redressal Mechanism

- 26. The project requires the constitution of the Grievance Redressal Committee's (GRC) at PIU as well state level. The main responsibilities of the GRC at both the levels is (i) provide support to affected people on problems arising from land/property acquisition; (ii) record AP grievances, and resolve them. The GRC is expected to resolve grievance of the eligible persons within a stipulated time of three weeks at PIU level and three weeks at state level.
- 27. The GRC has been constituted in all the three PIUs vide letter no. SHAJ/ADBII/SJSRP-16/2016/48 Dated 16 September 2016: The GRC at the state level is yet to be constituted. The composition of the GRC at PIU levels is reflected in table 10 and the copy of same is attached as Appendix 1.

28. The SHAJ up to end of this monitoring period has not received any grievance. In case any grievance is received by the project, the process detailed out in the resettlement framework will followed in it resolution. The DP will be free to approach court of law at their own risk and cost and during the project implementation.

L. Monitoring and Reporting

- 29. This semi-annual monitoring Report (SMR) is based on review of the monthly progress reports submitted by the three NGOs for the period from inception of the project in March 2016 to December 2016. The monitoring of the RP implementation has been carried out by CSC to review the compliance to the *ADB Safeguard Policy Statement (SPS, 2009)* and the RF agreed upon by SHAJ, Government of Jharkhand as part of the loan agreement of SJSRP.
- 30. The methods followed for the monitoring included (i) review and appraisal of sub-project reports and documents such as RP, RF, and monthly progress of NGOs (ii) consultations with RP implementing NGOs; and (iii) on-site observations and interactive meetings and discussions with the APs and other stakeholders.

M. Compliance status with the social safeguards covenants as stipulated in the loan agreement

31. The compliance status of social safeguards loan covenants as stipulated in the loan agreement is given in Table-11.

This complaint register has been initiated at the PIU level as soon as possible. Investigation of grievances will involve site visits and consultation with relevant parties like affected persons, contractors etc. 2.At the PIU level the following are the members of Grievance Redress committee
 - (i) DGM (PIU) SHAJ -Chairman
 - (ii) A representative from local NGOs or a local person of repute and standing in the society, elected representative from Zila Parisad –Member

 - (v) A representative from IP community or NGO for IP related issue-Member
