Summary of Environmental and Social Aspects

The project is categorized as C for environment. The project will support minor rehabilitation and extension works for existing school dormitory facilities under output 1, which is likely to have minimal or no adverse environmental impacts. Environmental implications of the project will be reviewed and a generic environmental management plan (EMP) will be developed for the design, construction, and operation period, respectively, and to ensure compliance with Mongolian environment impact assessment requirements. The generic EMP will be included in the GIM, together with environment safeguards-related contract clauses to be included in the civil works contracts, which will also cover the sequencing of works to avoid disturbance of school activities, and a simplified grievance redress mechanism.

Involuntary Resettlement

The project is categorized as C for involuntary resettlement category as it will not require any land acquisition or resettlement.

Indigenous Peoples

The project is categorized as B for indigenous peoples. The project will benefit school dormitory facilities, local government, and education department in Uvs aimag where several ethnic minority groups live a nomadic life. The ethnic minority issues as well as those related to herder families will be investigated. Measures to enhance inclusiveness and maximize the project benefits for the ethnic minority groups and herder families will be incorporated in the project design.

Stakeholder Communication, Participation, and Consultation

During Project Design Major stakeholders, including central government agencies, aimag governments, school management, dormitory staff, primary teachers, students, parents, herder families, ethnic minority groups, etc. have been consulted and results of the consultations have been incorporated into the project design.

During Project Implementation Through the project steering committee and sub-committees which will meet quarterly, the project's annual budgets and plans, quarterly and annual reports will be reviewed and discussed by central and local government agencies. Information on rehabilitation works of dormitories, student- and teacherorganized study, reading and extracurricular activities will be communicated to students staying in dormitories by dormitory teachers and other staff, and primary class teachers at the beginning of and during the school year. Parents of students staying in dormitories will be informed of rehabilitation works, and children's study, reading, and extracurricular activities in dormitories, schools and classrooms, at least annually through communication and outreach activities conducted by school management, dormitory and primary class teachers. Through training, workshops, reference materials and tools, information on revised duties and responsibilities, financing policy and standards for physical dormitory environment and services introduced under the project will be communicated to dormitory staff, teachers, school management, and accountants.
