#### I. INTRODUCTION

1. Highlighting "knowledge solutions" as a strategic priority, the Midterm Review of Strategy 2020 of the Asian Development Bank (ADB) identified the need to strengthen knowledge management to meet the demands of ADB's developing member countries (DMCs) through stronger institutional coordination. This would better capture the knowledge embedded in operations and ensure that the knowledge generated outside operations flows back to shape future operations.<sup>1</sup> ADB's midterm review also called for the adoption of a "One ADB" approach to knowledge solutions by closely integrating knowledge operations with country operations. A key means to operationalize this approach is the increased involvement of the recently established sector and thematic groups (STGs) in project development, and preparation of knowledge products and services (KPS) to reflect DMC demands and support ADB operations.<sup>2</sup>

#### II. ISSUES


2. The development issue at the core of this technical assistance (TA) is the need to provide DMCs with more and better knowledge solutions to help achieve sustainable development and manage matters related to environment and climate change. ADB's midterm review recognizes the fast-changing development landscape and that most DMCs have achieved, or are expected to achieve, middle-income status by 2020. For one, DMCs are now more closely integrated and connected thanks to improved infrastructure and information and communication technology. These developments necessitate enhanced knowledge support for ADB's lending and nonlending activities. Further, several events in 2015—(i) Third International Conference on Financing for Development in Addis Ababa in July, (ii) adoption of the Sustainable Development Goals (SDGs) during the United Nations' annual meeting in New York in September, and (iii) the 21st Conference of the Parties in Paris in December—have significantly changed or will change the development landscape in the region, and require ADB to respond better and faster to DMC needs.<sup>3</sup>

3. The nature of the challenges faced by DMCs continues to evolve and clients increasingly demand Finance++ solutions—financing matched with knowledge solutions and faster and better coordinated delivery of knowledge solutions. This evolution is reflected in the areas specified for DMC knowledge support in (i) ADB country partnership strategies, (ii) country knowledge plans (CKPs), (iii) lists of indicative knowledge products and events, and (iv) work plans of the STGs. The preparation of CKPs provides a mechanism for more consultations and coordination with ADB's operations departments and its resident missions, and informs the work of the STGs. The following figure illustrates the parties, relationships, and flows involved in delivering DMC-driven knowledge.

4. The TA will support the implementation of ADB's knowledge management strategy, and help tackle some critical weaknesses in ADB's delivery of knowledge solutions to its DMCs. For one, project-specific efforts are not being linked to each other to ensure that knowledge flows from one DMC to another. Second, the flow of information is insufficient to understand and respond to knowledge demand and supply by DMCs across the boundaries of ADB's operations departments, which creates a "silo" reality.<sup>4</sup> As confirmed in ADB's recent 2015 top task survey, ADB is valued for its knowledge sharing but the respondents, including DMCs, commented that ADB's "knowledge offerings are not such a good match for what they want."<sup>5</sup> Helping to break these silos, offer better matches, and accelerate the information flow, the TA will ensure that knowledge solutions developed under it will be leveraged, shared, and disseminated through various means, including ADB's k-Portal and k-Learn knowledge platforms, as well as sector and thematic training programs (including co-learning programs involving both DMC officials and ADB staff), such as the Asia Leadership Program on Sustainable Development and Climate Change.<sup>6</sup>

5. After consultations with ADB's operations departments, including resident missions and STGs, in particular during the formulation of their 3-year rolling work priorities and programs, the TA will target support in the following areas: (i) cross-sector, nexus, and crosscutting work (e.g., sustainable and smart cities; smart green infrastructure; food–energy–water–climate nexus;

gender and sustainable cities; mainstreaming of governance and capacity development into sector operations; natural resource management; public–private partnerships and capacity development in sector operations, as well as energy, health, social protection, and/or urban interconnected issues); (ii) new areas and approaches reflecting recent developments, such as the SDGs and climate change agenda; (iii) continuous learning, networking, and knowledge sharing with DMCs, including through co-learning programs, in partnership with k-hubs, centers of excellence (COEs), and external partners; and (iv) promotion of global and regional best practices for application in DMCs. Given the extent and urgency of DMC demand in these areas, however, many are currently under-resourced.

6. By supporting these new knowledge priorities of the STGs and ADB's operations departments, the TA will respond to the suggestions from the Knowledge Management Action Plan and Knowledge Operations Review meetings that ADB use its operations cycle to ensure that its knowledge solutions are relevant to DMCs and can be incorporated into operations. Taking into account the flows and links between the various parties (see the figure above), the TA will help ADB to deliver DMC-driven knowledge. One key need to be addressed by the TA is supporting resident mission country directors deliver just-in-time KPS, particularly requiring technical expertise, so that they can carry out their role as "knowledge custodians" in the design and implementation of CKPs.

### III. THE CAPACITY DEVELOPMENT TECHNICAL ASSISTANCE

#### A. Impact and Outcome

7. The impact will be that more integrated development solutions and services in DMCs are implemented. The outcome will be that more crosscutting and demand-driven knowledge solutions for DMCs are adopted.

### B. Methodology and Key Activities

8. The TA will support DMCs in the priority areas described in para. 5 and, based on indicative proposals from the STGs and operations departments for TA support in the first half of 2016, will have the following outputs:

- (i) **Crosscutting knowledge products and services released.** The TA will support cross-sector, crosscutting knowledge work, including but not limited to the following topics: water (institutional reform of water agencies) and gender; governance and infrastructure (open government initiatives to enhance infrastructure delivery, particularly in disaster-affected areas); environmental management and management of climate change and disaster risks (region-wide assessment of critical infrastructure and risks from climate change impacts); education and infrastructure (for skills development, technical and vocational education, and training projects); and water, agriculture, and energy for the water–food–energy nexus.
- (ii) Timely response to unplanned developing member country knowledge needs strengthened. The TA will support just-in-time delivery of KPS, as may be identified by ADB's operations departments and resident missions, so that ADB can respond quickly and flexibly to changing or unforeseen circumstances and demands. This output will address the needs of resident mission country directors when additional technical expertise is required urgently.
- (iii) **Knowledge in new emerging areas and approaches applied**. The TA will support (a) research on financing needs to deliver the social protection agenda of

the SDGs (e.g., estimating the financial size of national social policy gaps in relation to the new SDGs, and exploring financing options to close national social protection policy gaps in the region); (b) a study of sustainable transport priorities of DMCs and potential donor partners (for financial or in-kind contributions) and the application of new technologies and techniques in preparing a financing partnership facility to help DMCs achieve sustainable transport and meet financing gaps; and (c) a health study on innovative universal health-care projects, both nationally and subregionally.

Continuous learning (including co-learning), networking, and knowledge (iv) sharing for DMCs in partnership with k-hubs, centers of excellence, and external partners expanded. The TA will support co-learning training, networking and knowledge-sharing events for DMCs in partnership with k-hubs, COEs, and other external partners, including co-learning with DMC officials during (a) Social Protection Week, which will include focus on the new SDGs; (b) a climate risk management workshop to quantify risks and recognize and implement viable climate change adaptation responses in South Asia; (c) partnership with local government units and COEs to develop actions plans (including legal frameworks and the institutional and financial capacity of local governments) and carry out activities to achieve SDG 16 (peace, justice, and strong institutions) with a focus on better public service delivery; and (d) a conference with the United Nations Environment Programme on sanitation, and a regional study on fundable projects and policy reforms in the Asia and Pacific region.

#### C. Cost and Financing

9. The TA is estimated to cost \$1,500,000, which will be financed on a grant basis by ADB's Technical Assistance Special Fund (\$590,000 from TASF-V and \$910,000 from TASF-other sources).

#### D. Implementation Arrangements

10. ADB's Sustainable Development and Climate Change Department (SDCC), in close collaboration with the STGs and ADB's regional departments, will have overall responsibility for TA implementation. The Knowledge Sharing and Services Center (KSSC) in SDCC, in consultation with the Sector Advisory Service Division and the Social Development, Governance and Gender Division, will be responsible for receiving proposals from the STGs. Selection of the activities to be supported by the TA will be the responsibility of the TA advisory group, including the senior director of the Sector Advisory Service Division; director of the Social Development, Governance and Gender Division; and advisor of the SDCC and head of the KSSC. Proposals for TA support during the first half of 2016 have been received, and have been summarized on an indicative basis (para. 8). To meet urgent, unanticipated, and catalytic demands from DMCs, proposals for just-in-time activities may be submitted by the regional departments or resident missions at any time through the relevant STGs. Proposals for TA support during the second half of 2016 will be solicited in March 2016. The STG or regional department or resident mission that submitted an approved proposal will be the "activity owner" and will be tasked to implement the proposed activity, including delivering the respective KPS and conducting related activities, such as recruiting consultants, substantiating disbursements, and/or seeking any counterpart support from government agencies concerned. Given the role of ADB's KSSC in the development of knowledge platforms, such as k-Portal or k-Learn, as well as its responsibility for sector and thematic skills development programs, KSSC will support knowledge

dissemination and leveraging of the resulting KPS. The TA is expected to be implemented from December 2015 to April 2017.

- 11. The principles and process in selecting TA activities are:
  - (i) A proposal can be prepared and submitted by ADB staff in her/his capacity as an STG member or regional department staff (including resident mission staff) for review by the relevant STG chair(s) and technical advisor(s). The proposal should indicate (a) the issues to be addressed in one or more DMCs; (b) the outputs and implementation arrangements, e.g., the coordination arrangements, as relevant, with the relevant regional department(s) and STG(s), and the timetable; and (c) the means of knowledge sharing and dissemination (as relevant).
  - (ii) All proposed products and activities must be included in the STGs' work plans and/or reflect the demands of DMCs, as confirmed by the relevant regional department through the country partnership strategies and CKPs, and the country operations business plan's list of indicative knowledge products and services (as appropriate).
  - (iii) Proposals endorsed by the STG technical advisor(s) will be reviewed and prioritized by the TA advisory group. The implementation capacity of the "activity owner," including its ability and commitment to carry out activities on schedule and within budget, substantiate disbursements, and provide a brief activity completion report, will be considered in the selection of proposals.

12. Based on indicative activities and discussions with the STGs and regional departments, about 32 person-months of international and 37 person-months of national consultants are expected to be needed to support TA activities and monitor the TA. These will include individual international and national consultants with relevant sector or thematic expertise. Consultants will be engaged by ADB in accordance with its Guidelines on the Use of Consultants (2013, as amended from time to time). Contracts will be on an output-based or lump-sum basis. Disbursements under the TA will be carried out in accordance with ADB's *Technical Assistance Disbursement Handbook* (2010, as amended from time to time).

13. To ensure efficient and effective use of TA funds, terms of reference and project budgeting will be required, along with periodic reporting (including financial) on activity implementation. SDCC will regularly communicate with the relevant STG members or regional department officers and be responsible for overall TA implementation, including the preparation of reports. The TA will be monitored by assessing quality and timely delivery of outputs.

# IV. THE PRESIDENT'S DECISION

14. The President, acting under the authority delegated by the Board, has approved the provision of technical assistance not exceeding the equivalent of \$1,500,000 on a grant basis for Delivering Knowledge Solutions in Asia and the Pacific, and hereby reports this action to the Board.

# OUTLINE TERMS OF REFERENCE FOR CONSULTANTS

1. Individual consultants will be recruited, as necessary, to help carry out the sector and thematic group (STG) activities under the technical assistance (TA) (e.g., collaborative cross-sector, nexus, and/or crosscutting work; flagship knowledge events and publications; research to inform future operations; and continuous learning, networking, and knowledge sharing with developing member countries, k-hubs, centers of excellence, and other external partners). Expertise, scope of work, and tasks will depend on the requirements of each activity. Each consultant will need to have the necessary technical expertise, and project and/or research experience.

2. **Knowledge sharing and learning specialist** (national, 8 person-months). A knowledge sharing and learning specialist will be recruited to help identify and act on opportunities to distill and develop knowledge products and services based on the STG activities supported by the TA.

3. **Scope of work**. The specialist will assess the TA-supported STG activities and recommend knowledge products and services that can be developed or reused based on such activities. In consultation with the TA team leader and the Knowledge Sharing and Services Center (KSSC) of the Asian Development Bank (ADB), the specialist will then work with the ADB project officers (including the technical advisors and STG secretariat) and any consultant(s) responsible for such STG activities to produce such products and services, and leverage their impact, e.g., by including them in existing or new sector and/or thematic training programs, helping develop case studies, and sharing them on ADB knowledge platforms, such as k-Nexus, k-Learn, and k-Portal. The specialist will be recruited to work in ADB headquarters for 8 personmonths intermittently from December 2015 to April 2017.

4. **Minimum qualification requirements.** The specialist should have at least 5 years of relevant experience in knowledge sharing and dissemination, and designing and delivering learning programs. The specialist will work in, and will be a citizen of, the Philippines.

5. **Technical assistance administration consultant** (national, 12 person-months). An experienced TA administration consultant will be recruited for 12 person-months intermittently in ADB headquarters from December 2015 to April 2017 to ensure smooth and expeditious TA implementation. The consultant will support the TA team leader and other KSSC staff, ADB officers in the relevant STGs and regional departments, and the other TA consultants.

### 6. Scope of work:

- (i) Preparation of the TA implementation plan.
- (ii) TA coordination with the relevant STG secretariats regarding consultant recruitment and monitoring of procurement (if any) carried out by the STGs.
- (iii) Administrative support for international and national consultants, as needed.
- (iv) Preparation of periodic progress reports and, if needed, assistance to the TA team leader in convening meetings.
- (v) TA budget monitoring.
- (vi) Support in preparing TA progress and other reports.
- (vii) Ascertainment that TA information is published on the websites and/or in the enewsletters of ADB's Sustainable Development and Climate Change Department, the STGs, and regional departments in consultation with the TA team leader, knowledge sharing and learning specialist, and STG secretariats.
- (viii) Consolidation of inputs required for the preparation of the TA completion report.
- (ix) Performance of any other tasks required by the TA team leader.

7. **Minimum qualification requirements.** The TA administration consultant should have at least 3 years of relevant project administration experience—e.g., preparation of logistics and implementation plans; budget preparation and monitoring; preparation of project financial and other implementation reports; preparation of materials to promote and share knowledge (e.g., e-mail alerts, brochures, and website content); organization of meetings, workshops, and other events; interaction with ADB units to facilitate TA implementation; and use of standard Microsoft Office programs, such as Word, Excel, and PowerPoint. The consultant will work in, and will be a citizen of, the Philippines.
