Description	The capacity development technical assistance (TA) will develop an employment service system to expand opportunities for job seekers to access employment information in the formal sectors. It will strengthen capacity of central and provincial level institutions in terms of providing information on employment opportunities to job seekers, and job/career counseling to graduates from secondary school. The TA will complement the ongoing secondary education projects, TVET projects, and higher education projects financed by ADB and other development partners. It will develop Lao LDR's first online employment service.
