A local administrative assistant will also be hired for a maximum of 10 working days under Miscellaneous administration and support costs to support the preparation and implementation of the workshop. An international workshop facilitator will also be hired for each of the regional workshops, to ensure full participation of all participants and speakers in a professional manner.
