Under the CAREC Strategy 2030, there is a need to develop a new trade strategy that would discuss the increasingly intertwined issues of trade policy and trade facilitation while expanding to other trade-linkages within CAREC 2030's other operational clusters. For purposes of developing the CAREC Integrated Trade Agenda (CITA) 2030, a regional workshop was held in Bangkok in December 2017. Thereafter, a consultation paper with guiding questions was circulated for official comments of CAREC countries in February 2018. Subsequently, a series of stakeholders consultations were attended by trade-related agencies from CAREC members, development partners and international organizations in Almaty and Ulaanbaatar in March 2018, in Tbilisi and Beijing in April 2018 and in Islamabad in August 2018. A high-level consultation for private sector perspective was organized at the Astana Economic Forum in May 2018. The CITA Working Paper was reviewed at the inaugural meeting of CAREC's Regional Trade Group and Senior Officials Meeting in June 2018 and will be finalized at the National Focal Points Meeting in October for endorsement by the CAREC Ministerial Conference in November 2018. The proposed TA will support the implementation of CITA 2030, particularly, its rolling strategic action plan (RSAP) 2018-2020.
