Description	The proposed project will rehabilitate 34 kilometers (km) of Bishkek bypass road, linking the Central Asia Regional Economic Cooperation (CAREC) Corridor 1 (Bishkek Torugart Road) with CAREC Corridor 3 (Bishkek Osh Road). It will contribute to the climate resilience and sustainability of the road subsector projects, the institutional development and the diversification of livelihoods. The project derives synergies with the earlier assistance and adopts a cross-sectoral approach to integrated development in the region.	
Project Rationale and Linkage to Country/Regional Strategy	The proposed reconstruction of the Bishkek Northern Bypass Road (34 km) will contribute to regional cooperation through (i) linking the CAREC Corridors 1 and 3; (ii) providing global connectivity to the Bishkek Free Economic Zone (FEZ) and Dordoy Bazaar; and (iii) linking ABEC with Bishkek-Osh Road and Bishkek-Torugart Road. It will also improve domestic connectivity and reduce congestion in Bishkek city.

Environmental Aspects	Environment impacts will be mostly related to construction work and can be mitigated. Impacts during operations could be higher due to the increase in noise levels. Based on the initial assessment, the project is likely to be classified as Category B for environment impacts.	
Involuntary Resettlement	The proposed project road will follow the existing alignment but will entail widening of the road from two lanes to four lanes. According to the preliminary assessment, the project will likely involve major land acquisition, causing physical and economic displacement of people, and affecting more than 50 privately owned structures and agricultural land plots along the road. Therefore, it is anticipated that the project will be classified as category A for involuntary resettlement impacts. ADB financing is likely to cover both land acquisition and resettlement costs since the government has limited budget and is not in a position to allocate sufficient funds for land acquisition.	
Indigenous Peoples	There are no indigenous peoples in the project area, as defined in ADB's Safeguards Policy Statement, and thus, the project will be classified as category C for indigenous people's impacts.
