I. POVERTY IMPACT AND SOCIAL DIMENSIONS
A. Links to the National Poverty Reduction Strategy and Country Partnership Strategy The proposed loan to Far East Horizon Limited (FEH), through its PRC financial leasing subsidiary International Far Eastern Leasing Co., Ltd. (IFEL), will use the ADB loan proceeds to finance medical equipment and investments in the 12 least developed provinces ^a located in the central and western regions of PRC while the ADB A loan will be exclusively used for county hospitals serving the population where healthcare standards are significantly below urban areas. The project will finance the lease or purchase of modern medical equipment, as well as hospital fixed- asset investments (e.g. construction, expansion or refurbishment of hospital buildings or associated medical facilities) through sale and leaseback transactions. ^b The proposed loan is aligned with the ADB's Strategy 2030 in (i) addressing remaining poverty and reducing inequalities; (ii) promoting rural development by improving the accessibility, quality, and coverage of government and private health-care services; and (iii) accelerating progress in gender equality ^c . It is also consistent with ADB's operational plan for the health sector which emphasizes the need to strengthen the quality of health care services ^d . The project will contribute to the realization of the country partnership strategy for PRC 2016-2020 which highlights the role of private sector in ensuring accessibility to social development which includes health and education ^e , which is also in compliance with PRC government's prioritization of developing county hospitals to solve the problem of regional and urban-rural imbalance in healthcare resources.

The project will help address the accessibility of quality healthcare services especially to the rural population in the 12 least developed provinces located in the central and western regions of PRC, with per capita annual disposable income at least 20% below the national average.
C. Poverty and Social Analysis
 Key issues and potential beneficiaries. Poverty in PRC is experienced by 3.1% of its population. 2017 data of World Bank accounts for a total of 30.46 million Chinese living below the national poverty line^f. Poor communities are predominant in rural areas of central and western provinces. Income disparities in urban and rural areas also reflects disparities in the accessibility of quality healthcare services. The reported healthcare expenditure per capita in 2014 was CNY3,558 in urban areas and CNY1,412 in rural areas. Healthcare spending in PRC's regions also varies with higher spending per capita in eastern regions (CNY4,152 in 2015) than in central regions (CNY2,550) and western regions (CNY2,550). The loan will finance hospitals in lower-tier cities in the target provinces while the A loan will be deployed for the narrower purposes and be exclusively used for county hospitals. Population residing within or near the focused hospitals will greatly benefit from the modernization of medical equipment and improvement of hospital facilities. Impact channels and expected systemic changes. ADB's assistance will provide opportunities for FEH to widen its financial services through leasing and investment to hospitals in underserved areas. Through this assistance, FEH intends to contribute in the improvement of health service standards in rural areas and will provide opportunities for county hospitals to upgrade their equipment and facilities to provide quality healthcare services to underserved rural population, consistent with PRC's goal to achieve universal access to basic health services. The due diligence process will assess FEH's existing and likely future portfolio that ADB financing will be directed to as well as the corresponding social risks and impacts.

^b Under a sale and leaseback transaction, the hospital sells its existing medical equipment to FEH and obtains the finance in the form of sale proceeds. At the same time, it signs a financial lease contract with FEH to leaseback the equipment.
