Description	This KSTA will support the preparation and initial implementation of the Transport and Trade Facilitation Strategy of Armenia (2020-2040) through (i) development of National Transport and Trade facilitation Strategy (NTTFS); (ii) establishment of Road Safety Plan and Program; and (iii) development of Modal Action Plans. A well-prepared and NTTFS will be key to meeting the country's economic goals and will also improve international cooperation, not only with Armenia's neighbors, but also with the rest of the world. In addition, the NTTFS development will support the currently ongoing effort by Government of Armenia (GoA) to define a country-wide vision through the preparation of the updated Armenia Development Strategy.
Project Rationale and Linkage to Country/Regional Strategy	In 2008, the latest Armenia: Transport Sector Development Strategy, was developed, providing guidance for the transport sector up to 2020. As the time frame covered will come to an end soon and no other document is currently available governing the development of the sector, a new National Transport and Trade Facilitation Strategy (NTTFS) is needed to (i) apply lessons learned from previous strategy implementation; (ii) broaden the scope of transport planning including private sector involvement; (iii) expand on the scope to incorporate trade facilitation and traffic safety; (iv) mainstream gender, environmental, social and climate change aspects.
Impact	Promote long-term prosperity through the development of efficient, cost-effective, and environmentally and socially sustainable transport infrastructure and services, serving the whole nation. ADB will play an important role in supporting the global agenda of infrastructure development as a source of global growth. Infrastructure will remain a key priority to promote social and economic development.
