Description	The project is designed to prevent the poor and vulnerable groups from experiencing further marginalization and falling further into poverty including other affected households at risk of becoming poor with prolonged impacts of COVID-19. This project will complement and add value to other ADB assistance and COVID-19 humanitarian responses by focusing on the most vulnerable in addressing the short-term and medium-term impacts of the pandemic. The project has taken an innovative approach to bundle different types of interventions to more comprehensively respond to the needs of affected groups. Further, it will build the capacity of the existing social protection systems by exploring linkages with existing social protection programs. The project will focus on Fiji, Palau and Vanuatu. These are countries affected by COVID-19 largely from income and employment effects and consequent social impacts. The proposed outputs are elaborated below and will apply to participating countries based on their existing needs.	
Project Rationale and Linkage to Country/Regional Strategy	There are 18 coronavirus disease (COVID-19) confirmed cases and no reported deaths from Pacific developing member countries (DMCs). This refers to 16 cases in Fiji and 2 in Papua New Guinea (as of 12 April 2020). The Pacific DMCs were quick to impose precautionary measures and avail of immediate support from international organizations to prevent the spread of the virus given the region's high risk and vulnerability from disease outbreaks. The health system in the region is weak mostly affected by limited access to quality health services, lack of health facilities ar inadequate trained workforce. Lack of adequate infection control in hospitals would risk the spread of infections to other patients. There is also a high risk of the virus spreading quickly due to the communal living situations and extended family arrangements in the society. Unfortunately, most Pacific countries do not have the needed laboratory equipment to analyze the tests on site further posing difficulties to identify cases. Henc unprecedented increase in COVID-19 cases in the Pacific will potentially result to health system's collapse. The current impacts of COVID-19 in the region are largely from economic disruption. However, potential reduction in public health and essential health care services with the rise of COVID-19 cases could result to severe illnesses including indirect deaths that will deepen impacts on poverty.
