I. POVERTY ISSUES						
A. Links to the National Poverty Reduction Strategy and Country Partnership Strategy						
Jiangxi Ji'an is a prefectural level city in Jiangxi Province about 250 km south of the provincial capital of Nanchang. The city center is about 50 sq. km and has a population of about 500,000. The master plan for the center city envisions an expanded area of 150 to 200 sq. km and a population of up to 1.5 to 2.0 million by 2030. The Project is consistent with the ADB's PRC Country Strategy Program, especially the Pillar I of "Inclusive Growth and Balanced Development". Under Pillar I, ADB will help the PRC build a harmonious society and boost development in areas where growth and development are lagging. The economy of Jiangxi Province lags behind nearby provinces and remains relatively poor. Incomes have been rising rapidly in recent years but remain less than 60 percent of the national average.

The project will provide easy access to semi urban and rural households to be part of mainstream and benefit from economic development. The project will directly contribute in poverty reduction through (i) improved access to market and employment opportunities, (ii) attracting new enterprises, (iii) greater mobility for both self employed and wage earners, (iv) employment generation during project construction, and (v) new job opportunities in various services like transport hub, railway platform, etc. Based on ADB's *Handbook on Social Analysis*, a detailed poverty analysis will be carried to understand the issues and challenges related to poverty and how to address the same, especially for farmers in the villages affected by this urban development.

The households and businesses in Ji'an will directly benefit from the project. They will have better access to both rail and road transport system. The integrated hub approach will help in easy and safe mobility, which will provide access to new employment opportunities and enterprise development.

2. What are the potential needs of beneficiaries in relation to the proposed project?

The potential project beneficiaries expect that with greater access and improved rail and road transport they are supported for earning more income and improve their overall quality of life. The needs of affected rural villages will be assessed during the PPTA to identify measures to make this development more inclusive for them.

3. What are the potential constraints in accessing the proposed benefits and services, and how will the project address them?
The constraints include lack of information, livelihood planning, skills, need for investing in new enterprise, and road safety concerns. The Project will address the safety issue in the design itself, adopting an integrated approach. During the PPTA, a social development monitoring and action plan (SDMAP) will be prepared which will include skill enhancement and support programs to support beneficiaries to optimize benefit from project services.
