Status of Implementation Progress (Outputs, Activities, and Issues)	A. Program Progress The Program (Policy Loan) has two tranches. The first tranche of SDR 2,266,500 (\$3.0 million) was released on 13 April 2015 after the EA fully complied with all five policy actions. The release of the second tranche, which is equal amount to the first tranche, is expected by end 2017. B. Project Progress Output 1: Increased access to TVET programs, particularly for women and the poor: The Prakas and draft guidelines on qualifications requirements for VSC, which is an alternative pathway into the formal TVET system, will be approved in March 2017. Draft policies for conducting competency assessment and certification for recognition of prior learning and currency competency have been finalized and are expected to be approved by the NTB in July-August 2017. The guidelines on stipend management have been drafted. Construction of the first 3 dormitories will start in Q2 2017. Output 2: Improved quality and relevance of TVET system: The first quality assurance audit will be started in April 2017. As of December 2016, 28 assessors (2 female) have been trained on assessment methodology. Twenty master trainers (3 female) for 3 priority sectors have been trained as of February 2017 which constitutes 100% of the project target. The first intake of the improved skilled bridging program will start in Q2 2017. Three workshops at 3 provincial training centers, which are under construction, will be completed in July 2017, and 6 contracts are expected to be awarded by end of March. Output 3: Increased involvement of employers in TVET delivery: The policy on the internship program has been completed and is expected to be approved by the NTB in July-August 2017, and the internship program will start as soon as the implementation manual is approved. The role and responsibilities of the sector skills councils (SSCs) have been expanded, and 4 SSCs are expected to be established in Q2 or Q3 2017. The design of two provincial centers of excellence (CoEs) has started and the rehabilitation works will be completed in

### **Business Opportunities**

Consulting Services The project will be supported by a number of consulting service packages. Foremost of which are the project implementation consultants comprising of 587 person-months (112 person-months of international and 475 person-months of national consultants). The project implementation consulting services will be engaged through a firm on the basis of quality- and cost-based selection with an 80:20 weighting. Individual consultants (156 person-months of national consultants) will be recruited for supervision of civil works activities.

Procurement

All procurement of goods and works will be undertaken in accordance with ADB's Procurement Guidelines (April 2013, as amended from time to time) and the procurement plan prepared and agreed between the Government and ADB. Contracts for works above \$1,000,000 and goods, such as laboratory and workshop equipment, estimated at above \$500,000 will be awarded on the basis of international competitive bidding. Supply contracts for goods such as vehicles, computers and office equipment of more than \$100,000 and up to 500,000 will follow national competitive bidding procedures. Items costing at \$25,000 and up to \$100,000 will be procured through shopping with advertising. Supply contracts of less than \$25,000 will be procured by shopping without advertising. Civil works under the Project will consist of construction and/or rehabilitation of training facilities and laboratories. Civil works contracts estimated at \$1 million or more will be awarded on the basis of international competitive bidding. Civil works contracts of more than \$100,000 and up to \$1 million will be procured through national competitive bidding procedures, and contracts up to \$100,000 may be procured through shopping.
