#### I. INTRODUCTION

- 1. The Ministry of Education and Training (MOET) is implementing the Second Lower Secondary Education for the Most Disadvantaged Areas Project (LSEMDAP2, or the Project) in the 28 provinces of Viet Nam, through Loan № 3201-VIE(SF) from Asian Development Bank. Under the Project, a total of 200 lower secondary schools (LSSs) have been selected for assistance. In the screening and categorization for social safeguards, Category A subprojects are automatically excluded, while Category C subprojects shall be prioritized for financing. The subproject LSSs with minor impacts (Category B) may be considered subject to the preparation and implementation of a resettlement plan (RP) acceptable to ADB, as prescribed in 2009 Safeguard Policy Statement (SPS). The RP for Category B subproject shall be approved first by the Bank and disclosed in the ADB website before implementation by MOET.
- 2. Dien Bien province is in the Northwest region of Vietnam. It is bordered with Lai Chau and Son La provinces of Vietnam to the East and South, with Pu'er City, Yunnan, China, to the North, and with Phongsaly province in Laos to the West. Nine (09) beneficiary LSCs were selected for the Project, namely: (i) Na U Lower Secondary School; (ii) Sa Dung Ethnic Minority Semi-boarding & Lower Secondary School; (iii) Muong Lan Lower Secondary School; (iv) Tenh Phong Ethnic Minority Semi-boarding Lower Secondary School; (v) Khong Hin Lower Secondary School; (vi) Ta Phin Ethnic Minority Semi-boarding and Lower Secondary School; (vii) Huoi Leng Ethnic Minority Semi-boarding Lower Secondary School; (viii) Nam Vi Lower Secondary School; (ix) Nam Tin Lower Secondary School. They are located in eight (08) districts of the province. As screened, these LSCs are Category C subprojects in the Involuntary Resettlement and Category B subprojects in Indigenous Peoples categorization (Attachments 1 to 9), since no social impacts are expected inside the schools' premises. The Central Project Management Unit (CPMU) of LSEMDAP2 has submitted this Due Diligence Report (DDR) for information of ADB and to secure its "No Objection" for the award of civil works contract for the construction of school facilities.

#### II. APPROACH AND METHODOLOGY FOR DUE DILIGENCE

3. The CPMU has applied the selection criteria in evaluating the LSSs included in the long list. The criteria were developed during the PPTA. Given the large number of LSSs and their geographic locations, the CPMU sent questionnaires to be filled-up by school officials whose responses were the basis for screening and selection in producing the shortlist of LSSs. The school officials of shortlisted LSSs were then given two sets of questionnaires. The first set was used in gathering information on their proposed facilities and statistical data that justify their proposal. The proposed investments were then screened and made the reasonable distribution of facilities that are urgently needed. The second set was aimed to validate if land acquisition shall be required. National resettlement specialist conducted site survey and consultation with key officials of the Dien Bien PPMU and proposed schools during October 2015 to verify information provided by the Dien Bien PPMU.

#### III. THE PROPOSED FACILITIES

4. In all, the nine (9) LSSs of Dien Bien province will construct a total of 18 regular classrooms; 2 subject rooms; 6 libraries; 46 student dormitories; 41 teacher's housing rooms; 3 kitchens; 7 toilets for semi-boarding; and 3 toilets for common use. The construction of the Project's facilities will follow the MoET's Letter No. 2533/BGDDT-DATHCSKKN2 dated 27 May 2015. Typical dimensions of the project facilities is below:

#### IV. BRIEF PROFILE OF THE LSSs

# A. Na U Lower Secondary School

6. Established in 2003 at Na U village, Na U commune, Dien Bien district, Dien Bien province, the school has 3,533 m² of land (LURP is at Appendix 10) and only used 665 m² for the school buildings. In school-year 2015-2016, a total of 130 students were enrolled, 77 are male and 53 are female. The students include 35 in Grade 6, 34 in Grade 7, 31 in Grade 8, and 30 in Grade 9. 100% student of the School belongs to Mong EM group.

7. Enrolment of student during the last five (5) school-years was 125 in the school year 2010-2011; 88 in school year 2011-2012; 99 in school year 2012-2013, 105 in school year 2013-2014; and 118 in school year 2014-2015. Serving the Na U Lower Secondary School are 16 personnel, of which 3 are non-teaching staff and 11 are teachers with 6 male and 5 female. The School has three (3) EM teachers, two (2) male and 1 female.

#### B. Sa Dung Ethnic Minority Semi-boarding Lower Secondary School

- 8. The School was located at Na San A village, Sa Dung commune, Dien Bien Dong district, Dien Bien province. The school has 12,232 m² of land and only uses 1,700 m² for the school buildings. All student of the School belongs to Sa Dung commune. In school-year 2015-2016, a total of 587 students were enrolled, 254 are male and 333 are female. The school was established in 2011. The students were composed of 166 in Grade 6, 162 in Grade 7, 133 in Grade 8, and 126 in Grade 9. 100% student of the School are Mong and Thai EM group.
- 9. During the last five (5) years, enrolment was 451 in the school year 2010-2011; 496 in school year 2011-2012; 481 in school year 2012-2013, 509 in school year 2013-2014; and 560 in school year 2014-2015. 43 personnel are now serving the School, of which 5 are non-teaching staff and 35 are teachers with 24 are male and 11 are female. 20 of them are EM teachers with 14 male teachers and 6 female teachers.

### C. Muong Lan Lower Secondary School

- 10. The school has 6,309 m² of land at Lan B village, Muong Lan commune, Muong Ang district, Dien Bien province but and only uses 660 m² for the school buildings. The school was established in 2001 and during the school-year 2015-2016, a total of 353 students were enrolled, 185 are male and 168 are female. 94 student are now in Grade 6, 104 in Grade 7, 75 in Grade 8, and 80 in Grade 9. EM student account for 100%, comprising: Kho Mu,.
- 11. Enrolment of student during the last 5 year was 298 in the school year 2010-2011; 286 in school year 2011-2012; 307 in school year 2012-2013, 314 in school year 2013-2014; and 338 in school year 2014-2015. Muong Lan Lower Secondary School has 24 personnel, 6 are non-teaching staff and 18 are teachers with 13 are male and 5 are female. In which 3 are EM teachers, 3 are male teachers.

### D. Tenh Phong Ethnic Minority Semi-boarding Lower Secondary School

- 12. The school serves 100% EM student of H'mong EM group of Tenh Phong commune and during the school-year 2015-2016, a total of 164 students were enrolled, 85 are male and 79 are female. The students were composed of 47 in Grade 6, 40 in Grade 7, 38 in Grade 8, and 39 in Grade 9. The school was established in 2011 at Ten Hon village, Tenh Phong commune, Tuan Giao district, Dien Bien province. The school has 6,000 m² of land and only uses 350 m² for the school buildings.
- 13. For the last five (5) school-years, enrolment was 95 in the school year 2010-2011; 124 in school year 2011-2012; 135 in school year 2012-2013, 145 in school year 2013-2014; and 147 in school year 2014-2015. Tenh Phong Ethnic Minority Semi-boarding Lower Secondary School has 21 personnel, 3 are non-teaching staff and 18 are teachers with 10 are male and 8 are female. In which 3 are femal EM teachers.

### E. Khong Hin Lower Secondary School

14. Five (5) year ago in August 2010, the school was established at Khong Nura village, Khong Hin commune, Tuan Giao district, Dien Bien province. The school has the total land of 6,263 m² but only 590 m² used for the school buildings. The school serves all student of the Khong Hin commune. In school-year 2015-2016, a total of 322 students were enrolled, 168 are male and 154 are female. The students were composed of 77 in Grade 6, 66 in Grade 7, 100 in Grade 8, and 79 in Grade 9. All student are of Mong and Thai EM groups.

15. For the last five (5) school-years, enrolment was 190 in the school year 2010-2011; 222 in school year 2011-2012; 251 in school year 2012-2013, 309 in school year 2013-2014; and 327 in school year 2014-2015. Khong Hin Lower Secondary School has 27 personnel, 5 are non-teaching staff and 19 are teachers with 15 are male and 4 are female. In which 11 are EM teachers with 9 are EM male teachers and 2 are female teachers.

#### F. Ta Phin Ethnic Minority Semi-boarding Lower Secondary School

- 16. The school was established in 2003 at Ta Phinh 1 village, Ta Phin commune, Tua Chua district, Dien Bien province. The school has 5,563 m² of land and only uses 1,250 m² for the school buildings. The school serves the Ta Phin commune. In school-year 2015-2016, a total of 247 students were enrolled, 155 are male and 92 are female. The students were composed of 78 in Grade 6, 67 in Grade 7, 54 in Grade 8, and 48 in Grade 9. All student belongs to Mong EM group.
- 17. For the last five (5) school-years, enrolment was 168 in the school year 2010-2011; 183 in school year 2011-2012; 212 in school year 2012-2013, 204 in school year 2013-2014; and 223 in school year 2014-2015. Ta Phin Ethnic Minority Semi-boarding Lower Secondary School has 25 personnel, 4 are non-teaching staff and 21 are teachers with 15 are male and 4 are female. In which, 11 are EM teachers with 9 are EM male and 2 are female.

#### G. Huoi Leng Ethnic Minority Semi-boarding Lower Secondary School

- 18. The school was established in 2011 at Huoi Toong village, Huoi Leng commune, Muong Cha district, Dien Bien province. The school has 5,000 m² of land and only uses 1,199 m² for the school buildings. The school serves the Huoi Leng commune. In school-year 2015-2016, a total of 266 students were enrolled, 138 are male and 128 are female. The students were composed of 80 in Grade 6, 58 in Grade 7, 71 in Grade 8, and 57 in Grade 9. EM student account for 99%, comprising: Mong (242), Xa Phang (23).
- 19. For the last five (5) school-years, enrolment was 251 in the school year 2010-2011; 252 in school year 2011-2012; 261 in school year 2012-2013, 259 in school year 2013-2014; and 237 in school year 2014-2015. Huoi Leng Ethnic Minority Semi-boarding Lower Secondary School has 33 personnel, 6 are non-teaching staff and 23 are teachers with 10 are male and 13 are female.

#### H. Nam Vi Lower Secondary School

- 20. The school was established in 2009 at Nam Vi village, Nam Vi commune, Muong Nhe district, Dien Bien province. The school has 3,000 m² of land and only 980 m² used for the school buildings. In school-year 2015-2016, a total of 334 students were enrolled, 207 are male and 127 are female. The students include 97 in Grade 6, 100 in Grade 7, 70 in Grade 8, and 67 in Grade 9. EM student account for 100%, comprising: Mong (316), Thai (18),.
- 21. For the last five (5) school-years, enrolment was 135 in the school year 2010-2011; 128 in year 2011-2012; 105 in school year 2012-2013, 176 in school year 2013-2014; and 260 in school year 2014-2015. Nam Vi Lower Secondary School has 17 personnel, among them 16 are teachers with 9 are male and 7 are female. The School has seven (7) teacher of EM group with 5 are EM male teachers and 2 are female teachers.

#### I. Nam Tin Lower Secondary School

22. The school was established in 2013 at Nam Tin 2 village, Nam Tin commune, Nam Po district, Dien Bien province. The school has 12,000 m² of land and only uses 939 m² for the school buildings. The school serves the Nam Tin commune. In school-year 2015-2016, a total of 323 students were enrolled, 202 are male and 121 are female. The students were composed of 103 in Grade 6, 108 in Grade 7, 87 in Grade 8, and 25 in Grade 9. 99% of the School student are H'Mong.

23. For the last two (2) school-years, enrolment was 151 in school year 2013-2014; and 259 in school year 2014-2015. Nam Tin Lower Secondary School has 19 personnel, 18 are teachers with 14 male and 4 female. In which 9 are male EM teachers.

#### V. ASSESSMENT OF SOCIAL IMPACTS

- 24. There are no social impacts expected arising from land acquisition in any of the selected LSSs in Dien Bien Province. The school premises are enclosed with concrete or wooden fences as protection from encroachers, and neither a house nor structure of private person was allowed by the school administration. The proposed facilities will be built within the existing respective school premises, so it is no need to acquire any land. The project will improve working, studying and living conditions for students and teachers.
  - Na U Lower Secondary School. This school proposed buildings which covers four (04) student dormitory rooms, five (05) teacher's housing rooms, and one (01) toilet for semi boarding. The proposed area for buildings is 453 m² within the school premise of 3,532 m². The structures will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety and normal operation for students and third-party and local environment
  - Sa Dung Ethnic Minority Semi-boarding Lower Secondary School. This school proposed buildings for four (04) classrooms, one (01) subject room; one (01) library, six (06) student dormitory rooms, eight (08) teacher's housing room, one (01) toilet for semi boarding, and one (01) toilet for common use. The proposed land for these buildings is 1,130 m² within the school premise of 12,231 m². The structures will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety and normal operation for students and third-party and local environment.
  - **Muong Lan Lower Secondary School**. This school proposed buildings for four (04) student dormitory rooms, five (05) teacher's housing room, and one (01) toilet for semi boarding. The proposed area for buildings is 428 m² within the school premise of 6,309 m². The structures will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.
  - Tenh Phong Ethnic Minority Semi-boarding Lower Secondary School. This school proposed buildings with four (04) classrooms, one (01) library room, and three (03) teacher's housing rooms. The proposed area for buildings is 481 m² within the school premise. The structures will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.
  - Khong Hin Lower Secondary School. This school proposed buildings for two (02) classrooms, one (01) library, eight (08) student dormitory rooms, five (05) teacher's housing room, one (01) kitchen and one (01) toilet for semi boarding. The proposed area for buildings is 428 m² within the school premise of 6,263 m². The structure will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.

- Ta Phin Ethnic Minority Semi-boarding Lower Secondary School. This school designed buildings which serve for (01) subject room; one (01) library, ten (10) student dormitory rooms, four (04) teacher's housing room, and one (01) toilet for semi boarding. The proposed area for buildings is 734 m² within the school premise of 5,563 m². The structure will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.
- Huoi Leng Ethnic Minority Semi-boarding Lower Secondary School. This school proposed buildings for six (06) student dormitory rooms, four (04) teacher's housing rooms, one (01) kitchen, and one (01) toilet for semi boarding. The proposed area for buildings is 462 m² within the school premise of 5,000 m². The structure will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.
- Nam Vi Lower Secondary School. This school proposed buildings which include four (04) classrooms, one (01) library room, four (04) teacher's housing rooms, and one (01) toilet for common use. The proposed area for buildings is 397 m² within the school premise of 3,000 m². The structure will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.
- Nam Tin Lower Secondary School. This school proposed buildings for four (04) classrooms, one (01) library room, eight (08) student dormitory rooms, three (03) teacher's housing rooms, one (01) kitchen, one (01) toilet for semi boarding, and one (01) toilet for common use. The proposed area for buildings is 803 m² within the school premise of 12,000 m². The structure will be built within the existing school compound. No land acquisition is required and no third-party user will be affected. Adequate safety measures should be applied by contractor/s during construction phase to ensure safety for students and third-party and local environment.

#### VI. GRIEVANCE REDRESS MECHANISM AND IMPLEMENTATION ARRANGEMENT

- 25. The CPMU under MOET's authority will coordinate with the Dien Bien PMU to implement the Project and settlegrievance of local people (if any) before, during or after construction. PPCs, DPCs, CPCs and chiefs of villages and other local social organizations such as the Women's Union, the Fatherland's Front, and traditional EM leaders also take part in grevience redress.
- 26. Grievances related to any aspect of the subprojects of LSEMDAP II will be handled through negotiation aimed at achieving resolution. A grievance redress mechanism (GRM) established aim to address grievances, complaints, and queries of local people regarding compensation and adverse impacts (if any) on people including ethnic minorities in a timely and satisfactory manner. Complaints can be in written or in verbal narrative. In the case of verbal complaints, the designated commune or district officials will record the complaint during the first meeting with the complainant.
- 27. The Dien Bien PMU officers will serve as grievance officers. The designated commune officials will attempt to settle the issues at the commune level through appropriate community consultations. All meetings will be recorded, and copies will be provided to the

complainants. A copy of the minutes of meetings and actions undertaken will also be provided to CPMU and ADB upon request.

- 28. Under the project, a GRM with three stages was established for seeking resolution of complaints. If grevience is still unresolved, it can be elevated to a court of law for resolution. The complainant will be exempted from all administrative and legal fees that might be incurred in the resolution of their grievances and complaints. The GRM process is below.
- (i) First Stage, Commune Peoples' Committee (CPC). The complainant may register his/her complaint verbally or in writing to any member of the CPC, either through the Village Chief or directly to the CPC. The CPC will register the complaint and meet the complainant. The CPC secretariat will document and keep the files of all complaints that it handles. The CPC has up to 30 days or 45 days (for complex cases) to resolve the complaint. If the complaint is not resolved within the given days or the complainant does not satisfy with decision of CPC on his/her case, he/she can bring complaint to the DPC.
- (ii) Second Stage, District Peoples' Committee (DPC). The complainant may bring the case to any member of the DPC. The DPC has up to 30 days or 70 days (for complex cases) to resolve the complaint. The DPC documents and maintains a file of all complaints that it handles and informs the PMU (or DCRC) of any determination, decision made. The PMU (DCRC) will support the DPC to resolve the complaint. The DPC notifies the complainant of its decision. If the complainant does not hear from the DPC within the given days, or if the complainant does not satisfied with the decision taken on his/her complaint, the complainant may bring the case, either in writing, to any member of the PPC.
- (iii) Third Stage, Provincial Peoples Committee (PPC). The PPC has up to 30 days or 70 days (for complicated cases or complaints in remote areas) to resolve the complaint. The PPC documents and files all complaints that it receives. Wthin 45 days from the date of receipt of the decision of the PPC Chairperson and if the complainant does not agree with the decision, the complainant may bring the case to the law court. The time limit for appeal should not exceed 60 days (or 70 days for complicated cases) from the date of acceptance. The agency that receives the complaint will record the proceedings done for the complaint.
- 29. All grievance and resolution of grievances, if any will be subject to monitoring. Internal monitoring will follow-up the progress of resolution of grievances, and compliance with the overall social safeguards policy.
