Description	The project will promote commercializing and exporting agricultural produce and processed products along agro-value chains to stimulate agriculture's role in economic growth and poverty reduction in Samoa. It will provide business support services and financing to agribusinesses.				
Project Rationale and Linkage to Country/Regional Strategy	Samoa has yet to return to pre-tsunami (2009) economic growth levels which the government seeks to redress through promoting tourism and agriculture. Revitalizing agriculture and increasing exports feature therefore prominently in the government's policy framework including the Strategy for Development of Samoa, the Agricultural Sector Plan, and the National Export Strategy. In the agribusiness subsector, including commercial farming and agro-industrial enterprises, trade statistics show a total agriculture food export (fresh and processed) decline from ST61 million in 2002 to ST45 million in 2012. Agribusinesses are critical for stimulating agricultural production. Even though their total number is small, they support many mall holder farms through supply chain arrangements.

Project Outcome

Selected commercial agribusinesses grow sustainably			
Eight businesses have been financed, and five are in the pipeline to obtain approval by the second quarter of 2017.			
Partner agribusinesses are provided with suitable financing instruments Partner agribusinesses are provided with business support services Project is efficiently and effectively managed			
In total, the banks have provided around \$0.88 million in loans. Out of the \$3 million disbursed to the partner banks, \$0.28 million in cash collateral and \$0.18 million in supplemental seed capital have been utilized. The banks were able to extend loan terms for up to 7 years at interest rates that are 3_%-4% lower than the prevailing commercial lending rates in Samoa. Four partner businesses have so far been provided business support services. The Government of Australia has confirmed its intent to provide additional cofinancing of A\$1 million to the project.

Community consultation will be required for agro- industrial facilities in accordance with Samoan environmental impact assessment regulations.
