RISK ASSESSMENT AND RISK MANAGEMENT PLAN

This risk assessment and risk management plan for the Bhutan Health Sector Program summarizes the key risks and mitigation measures identified during due diligence in accordance with Asian Development Bank (ADB) Guidelines for Implementing the Governance and Anticorruption Action Plan II.¹ Project-related risks concern (i) technical aspects, (ii) governance and capacity issues in financial management and procurement, and (iii) environmental safeguards. Risks are rated substantial (S), moderate (M), or low (L). The proposed mitigation measures were discussed and agreed with the government and built into the design of the program.² The risks, rating, mitigation measures, and responsible agencies are summarized in the table below.
