I. THE TECHNICAL ASSISTANCE SUBPROJECT

A. Overall Progress of the Technical Assistance Cluster

- 1. The knowledge and support technical assistance (TA) cluster "Advancing the 2030 Agenda for Sustainable Development, 2021–2024" was approved by the President on 27 July 2021 and aims to support ADB developing member countries (DMCs) to advance implementation of the Sustainable Development Goals (SDGs), in line with ADB's Strategy 2030.
- 2. The TA cluster has four subprojects and is financed on a grant basis from the ADB's Technical Assistance Special Fund (TASF-other sources). It was identified as a Strategy, Policy and Partnerships Department (SPD) corporate priority TA in 2021. It is implemented by the Results and Aid Effectiveness Division (SPRA) of SPD, the ADB focal point for the SDGs.

B. Subproject Outcome

3. The TA will have the following outcome: Higher-quality programs and projects that advance the SDGs developed and delivered by ADB DMCs.¹ Subproject 1 will help deliver the TA cluster's overall outcome by supporting a suite of knowledge products, platforms, research and e-learning, designed to enhance knowledge and skills of DMCs that they can then use to develop policies, plans, strategies, and programs that advance SDG attainment.

C. Subproject Outputs, Methods, and Activities

- 4. Subproject 1 will support the three TA cluster outputs through the following activities:
- 5. Output 1: DMC capacity to align programs and financing with the 2030 Agenda for Sustainable Development enhanced. Subproject 1 will support knowledge, capacity building, and policy dialogue with selected DMCs on SDG implementation. Activities will include:
 - (i) Knowledge on SDG progress in Asia and the Pacific and support for regional policy dialogue. Through the Economic and Social Commission for Asia and the Pacific (ESCAP) ADB United Nations Development Programme (UNDP) SDG partnership, subproject 1 will support knowledge, providing a regional perspective on the theme of the 2022 High-Level Political Forum (HLPF) on the SDGs: Achieving sustainable and just economies and promoting sustainable urban development.² ESCAP as the secretariat of the partnership will be supported to implement these activities. The work will build on the 2021 ESCAP ADB UNDP report supported under TA 9130³ which explored emerging risks and dimensions of uneven recovery⁴ that increases inequalities within and between countries in Asia and the Pacific. In addition, the TA will support continued updates and upgrades to the ESCAP ADB UNDP SDG Data portal.⁵ These knowledge products

will be featured at the 2022 Asia Pacific Forum on Sustainable Development, as well as the 2022 HLPF, and informed by sub-regional policy dialogue. Government, civil society and other regional stakeholders participate actively in these processes. Economic Research and Regional Cooperation Department) statistics division and Sector and Thematic Groups will be actively engaged in these activities, including through the SDG Working Group process. These activities aim to build understanding of opportunities to advance the SDGs in light of the effects of COVID 19 on the region's development progress.

- (ii) Assessments of national SDG implementation and financing needs. Three countries, i.e., Lao PDR, Mongolia, and Sri Lanka, have been identified in consultation with the regional department focal points of the SDG Working Group, relevant resident missions, and counterpart governments to complete country level SDG implementation studies. The approach to these studies will build on the SDG implementation snapshot methodology that was developed by ADB and UNDP with inputs from the Sustainable Development Solutions Network under TA 9130, and include a strong emphasis on institutional and capacity needs. Partnerships with UNDP and other development partners in the focus countries will be explored to deliver these studies, in consultation with the regional department and resident missions. Country efforts to develop integrated national financing frameworks could also be supported and leveraged. These products will be developed with active input and engagement of relevant government agencies, including those responsible for gender equality issues, and the knowledge outputs will be disseminated to these target audiences. They aim to help DMCs and associated stakeholders develop programs and strategies that can advance progress on the SDGs.
- (iii) Produce an updated review of evolving approaches to results and impact management for the SDGs, with a focus on private sector tools and standards complemented with convening key players developing and applying SDG impact standards. The outputs of this review will support joint work among the multilateral development banks to develop common approaches to aligning finance and results with the SDGs, including for private sector operations. This activity will inform potential activities under future sub-projects to help private sector adoption of common standards to help steer finance towards SDG advancement.
- Output 2: DMC knowledge of good practices and lessons from operations increased. Output 2 will support documentation, analysis, and dissemination of experiences and lessons from projects and programs that advance the SDGs, particularly from ADB-financed projects, and from selected partner countries or regional fora. Subproject 1 will support three main activities: (i) review best practices in results management to capture how operations target poverty and the needs of the most vulnerable people; (ii) review evolving methodologies to better understand the effects of ADB projects on jobs and livelihoods; and (iii) in conjunction with the Sustainable Infrastructure Foundation, initiate stock-taking of opportunities for DMCs to make use of ADB's Green Resilient Inclusive and Sustainable quality infrastructure assessment tools that have been incorporated into SOURCE, the multilateral platform for quality infrastructure. Operational departments, DMCs, and other stakeholders will be engaged to identify key issues that would benefit from review and analysis under subproject 2 of the TA. These issues are at the heart of

the 2030 Agenda for sustainable development, and the knowledge work aims to identify and foster the uptake of good practices in these areas.

7. Output 3: DMC capacity for result-based project design and management strengthened. Subproject 1 will deliver e-learning to approximately 30 officials from executing and implementing agencies, and scope learning needs and demand to strengthen and expand on delivery methods and the curriculum, including linkages to the SDGs, under subproject 2. The elearning course will cover basic results management practices, referencing the updated design and monitoring framework (DMF) guidelines, including data collection, recording, analysis, and reporting. Trainings will provide practical guidance, and make use of participatory and interactive approaches, including coaching sessions, to provide experiential learning and encourage participants to apply these practices on the job. The targeted participants are project directors, planners, implementers, and monitoring staff, including gender focal points, from executing and implementing agencies of planned and recently approved ADB-financed projects. The technical assistance supervising unit (TASU) SPRA will work with ADB operational departments, resident missions, and DMC partners to: (i) identify participants for training programs, considering the roles and responsibilities of DMC officials, and ADB's project pipeline; (ii) analyze DMCs' existing project monitoring and evaluation arrangements, systems, and tools, and identify ways to build on and improve these; and (iii) identify common results-based management challenges for ADBfinanced operations in DMCs, and ensure that solutions to these are emphasized in the curriculum. Participants working on M&E and/or strengthening DMF, and who are committed to follow through the course requirements, will be prioritized. Participants are expected to apply the knowledge, skills, and tools they gained within their role designing and implementing projects and share them with their colleagues. These initial activities will lay the groundwork for further efforts in subsequent sub-projects to build DMC capacity for results-based project design and management.

D. Subproject Cost and Financing

8. The TA subproject 1 is estimated to cost \$500,000, to be financed on a grant basis through ADB's TASF-other sources. The key expenditure items are listed in Appendix 2.

E. Subproject Implementation Arrangements

9. SPRA will administer TA subproject 1 with the following planned implementation arrangements are summarized in Table 1.

10. **Consulting and ADB procurement.** Each of the subproject 1 outputs will require the services of international and national experts including SDG financing and thematic specialists, results communication specialists, workshop facilitators, research analysts, infrastructure project support specialists, and publication and website support specialists. Experts will be contracted via consulting firms or as individuals depending on the scope and requirements of the planned activities. All procurement will be in accordance with ADB's Procurement Policy (2017, as amended from time to time) and its associated project administration instructions and/or staff instructions. Indicative implementation arrangements including the recruitment of experts and the associated selection method envisioned under subproject 1 are summarized in Table 1. The requirement for the type of expertise and the length of inputs are specified in outline terms of reference. Under outcome 2, delivery of lessons in developing quality infrastructure that supports the SDGs will leverage ADB's ongoing support for the SOURCE infrastructure project preparation platform which is managed by the Sustainable Infrastructure Foundation (SIF). SIF will therefore be engaged through single-source selection.
