These key reform an aligned with the government's reform agenda for public sector management outlined in Pakistan's Vision 2025, the national destrategy, the medium-term budget strategy, and Asian Development Bank's (ADB) country partnership strategy for Pakistan, 2 TRTA also aligns with the Central Asia Regional Economic Cooperation (CAREC) program, particularly the CAREC Integrated Tra 2030 and Digital Strategy 2030 that promotes trade through applying digital technologies. The proposed transaction technical assistance (TRTA) will focus on the first and third key reform areas. The TA will, through the Finance (MOF) and Federal Board of Revenue (FBR), support the implementation of critical tax administration, pension system, institutional and capacity development reforms in Pakistan. The TA for the development and implementation of the second key for improving the quality of public expenditure and cash management, will be provided through an ongoing regional TA facility Public Financial Management and Tax Policy.
