Implementation Status and Key Decisions



The project became effective during this reporting period, on 30 December 2015.

Land acquisition: Acquisition procedures are continuing on target. There are a number of locations in which lands have been completely acquired and where works can begin as planned while acquisition continues.

Road works: Bids received and evaluated for Route Nationale 12 and Route Regionale 133. Works on these roads expected to begin in first half of July 2016. Call for proposals on Route Nationale 4 completed on 24 May.

Technical assistance: Requests for Expressions of Interest for the two technical assistance contracts were published in Tunisia on 19 and 31 May and on the United Nations Global Marketplace on 31 May and 01 June.

Support for technical assistance activities: A workshop on Performance Based Contracting (PBC) was held by the Ministry of Equipment, Housing and Land Planning in Tunis on 12 April with participation by World Bank experts. The purpose of the workshop was to familiarize the Tunisian road maintenance community with the concept of PBC and strengthen understanding in advance of the PBC feasibility study financed by the grant.


