1 Summary

1.1 Introduction to the Project

Located in southwestern Yunnan Province, Pu'er City has a land area of 45,000 km², being the largest prefecture/city in Yunnan, and governs 9 counties, one district and 103 townships, with a population of 2.546 million, in which minority population accounts for 61%. Pu'er is the only prefecture/city of China bordered by Vietnam, Laos and Myanmar, with a border line of 486 kilometers, enjoying superior traffic and geographic advantages.

In order to promote the city's economic and social development, the Pu'er Municipal Government (PMG) plans to upgrade and reconstruct the existing transport infrastructure, and has thereby proposed the Yunnan Pu'er Regional Integrated Road Network Development Project (the "Project").

The Project aims to improve regional cooperation and trade development in Pu'er City, and traffic conditions in rural and frontier areas of Pu'er City. The Project has three outputs: 1) Regional Roads Development; 2) Rural Access Improvement; and 3) Institutional Development.

- Output 1: Regional Roads Development: This comprises (i) upgrading and new construction of 228 km of class III/IV/IIIhighway between Ning'er–Jiangcheng–Longfu; (ii) upgrading and new construction of the 48.75 km Menglian to Meng'a section of the Lancang–Menglian–Meng'a class III/IV border road mainly to class II standard; (iii) development of trade facilities at the Meng'a Material Transit Centre (MTC); and (iv) improving the safety of these roads by introducing safety measures determined by the ChinaRAProad safety design decision-making tool.
- Output 2: Rural Access Improvement: This will provide all-weather access to administrative villages and links with higher level roads. It comprises (i) upgrading to class IV standard of 600 km of village earthen or gravel roads selected in accordance with the rural road assessment criteria,(ii) spot improvements on up to 1,200 km of connecting lower level village roads, (iii) introduction of five new village bus service routes on a pilot basis, and (iv) a gender focused rural road maintenance program.
- Output 3: Institutional Development: This will address the limited implementation capacity of PMG. A project management consultant will assist the PMG to implement and monitor the project in accordance with ADB procedures. The project will finance a 3-year program of international and domestic training in financial and project management, road maintenance engineering, road maintenance practices, road safety, environmental management, social safeguards management, and human, drugs and wildlife trafficking enforcement.

ADB approved the ordinary fund loan of \$200 million on December 8, 2014, and signed the loan agreement on June 25, 2015. The loan took effect on October 20, 2015, and the closing date is June 30, 2021.

1.2 The Subproject and Resettlement Impacts

1.2.1 The Subproject

The Ning'er–Jiangcheng–Longfu Highway is a subproject of the Project (hereinafter, the "Subproject").

The Ning'er–Jiangcheng–Longfu Highway beings with K3+800 north of Ning'er Town, and ends with the No.3 China-Vietnam Boundary Marker, with a full length of 228.078km. The segment from the starting point to Laozhaozhai (25.136km) has a design driving speed of 40kph and a roadbed width of 8.5m, and the segment from Laozhaozhai to the endpoint (202.942km) has a design driving speed of 30kph and a roadbed width of 7.5m (where the KM231+706.30~KM234+069.52 segment has a roadbed width of 12 m).




Figure 1-1 Route Map of the Subproject

1.2.2 Resettlement Impacts

According to the RP approved by ADB in October 2015, 23 villages in 6 townships in Ning'er and Jiangcheng Counties, Pu'er City will be affected by LA and HD for the Subproject, in which 17 villages are affected by both LA and HD, and 6 affected by LA only.

2,245.554 mu of rural collective land will be acquired permanently, 970.808 mu of state-owned land occupied and 150 mu of land occupied temporarily.

Residential houses of 25,069.38 m² will be demolished, all being rural residential houses, affecting 315 households with 1,178 persons, including 15,245.02 m² in masonry concrete structure (60.81%), 6,923.02m² in masonry timber structure (27.62%) and 2,901.34m² in simple structure (11.57%).

In sum, 1,620 households with 8,729 persons will be affected by LA and HD for the Subproject, in which 1,305 households with 7,551 persons will be affected by LA only, 79 households with 301 persons by HD only, and 236 households with 877 persons by both LA and HD. See Table 1-3.

1.2.3 Changes of Resettlement Impacts

Paragraph 32 on "LA and resettlement" in ADB Loan Review Memorandum (December 2016) states, "The ADB mission is seriously concerned about the increase of the LA area in the former RP¹ from 2,219 mu to 5,900 mu, and suggests that the Pu'er PMO update the former RP based on the construction design." For this reason, the Pu'er PMO reviewed the Subproject's LA and HD impacts together with the design agency, Ningjiang Highway Construction Headquarters, Ning'er and Jiangcheng County LA and HD Management Offices, and township governments concerned, and updated the former RP on this basis to protect the APs' lawful rights and interests.

From June to November 2016, the Ningjiang Highway Construction Headquarters, and the Ning'er and Jiangcheng County LA and HD Management Offices re-measured the land used for the Subproject based on the reviewed construction drawings. In December 2016, the Pu'er PMO reviewed the Subproject's resettlement impacts in the 6 affected townships in Ning'er and Jiangcheng Counties, and conducted a field survey on all construction sites.

The Pu'er PMO submitted the updated report to ADB in February 2017, but it has not been approved by ADB.

The updated RP of the Subproject indicates that the Subproject's resettlement impacts are as follows:

1) 6,101.9 mu of rural collective land will be acquired, 3,882.7 mu more than the former RP; the number of AHs rises by 1,068 while the affected population drops by 319;

2) Rural houses of 40,131.38 m² will be demolished, 15,062 m² more than the former RP; the number of AHs and the affected population rise by 9 and 64 respectively;

3) Due to the substantial growth of collective land, the resettlement budget is now 341.209 million yuan, 233.093 million yuan more than the former RP.

1.3 External Resettlement M&E

1.3.1 Basis

The basis for M&E of the Subproject includes:

- > Applicable state laws and regulations
- > ADB's Safeguard Policy Statement (June 2009)
- > RP approved by ADB (October 2015) and the updated RP² (February 2017)
- M&E contract
- > Terms of reference for resettlement M&E
- > Other documents related to the Subproject

1.3.2 Scope

This report is the No.2 external M&E report of the Subproject, and aims to sum up the resettlement work of the Subproject as of December 31, 2016, find out issues in resettlement and propose solutions accordingly. This report covers: 1) LA and resettlement implementation; 2) temporary land occupation; 3) production development; 4) HD and house reconstruction; 5) resettlement measures; 6) fund disbursement, use and management; 7) establishment and operation of resettlement agencies; 8) information disclosure and grievance redress; 9) production level and living standard of APs; and 10) income variation, etc.

1.3.3 Procedure

- Preparing the terms of reference for resettlement M&E
- Sampling plan design
- Baseline survey
- > Establishing an M&E information system
- Follow-up survey
- > Data compilation and analysis
- Preparing a M&E report

1.3.4 Methods

1) Monitoring methods

<u>Literature study</u>: Documents, agreements, statistical reports, etc. on LA, HD and resettlement were referred to and verified.

Door-to-door interview: The task force conducted a survey on AHs, covering LA area confirmation, compensation payment, etc. These sample households will be followed up in the next round of M&E until their income is restored.

<u>FGD</u>: FGDs were held with the LA and HD agencies, township governments, village committees and AHs to learn information on LA, HD and resettlement. 12 FGDs were held, with 19 participants in total, including 10 women, accounting for 52.6%.

<u>Key informant interview</u>: 8 interviews were conducted with heads of the LA and HD IAs, village heads, heads of AHs, women and old people to learn construction and investment progress, public participation, potential issues and suggestions, local socioeconomic profile, etc.

<u>Field investigation</u>: A field investigation was conducted to learn the progress and effectiveness of resettlement, and identify existing or potential issues.

2) Evaluation methods

<u>Statistical analysis</u>: A comprehensive statistical analysis was performed on resettlement implementation, including resettlement progress, resettlement planning and completion, fund availability, etc.

<u>**Comparative analysis**</u>: A comparative analysis was performed on the resettlement effect, including horizontal and vertical comparison of production level and living standard.

<u>**Participatory evaluation**</u>: The APs and local residents evaluated the resettlement effect, and gave opinions and advice by means of FGD, questionnaire survey, etc.

1.3.5 Scope of this Report

1) Scope of M&E

This round of M&E covered the resettlement implementation of the Subproject in Ning'er Town, Liming Xiang, Mengxian Town, Baozang Xiang, Menglie Town and Qushui Town.

2) Time limit of M&E

The period of this round of M&E for resettlement implementation is from July 1 to December 31, 2016.

2 Organizational Structure

2.1 Agencies

To ensure successful resettlement as desired, a systematic organizational structure must be established during project implementation in order to plan, coordinate and monitor resettlement activities.

PMG is the executing agency of the Project, responsible for overall project implementation, and PMTB is the implementing agency, responsible for the fulfillment of the outputs and routine project implementation. The Pu'er PMO has been established at PMTB for project coordination and management.

In January 2016, PTIG established the Ning'er–Jiangcheng–Longfu Highway Construction Headquarters as instructed by PMG, responsible for the construction, quality, progress and safety management of the Ning'er–Jiangcheng–Longfu Highway, and the coordination of LA, HD and preparation with the Ning'er and Jiangcheng County Governments.

In June 2016, the Ning'er County LA and HD Management Office was established, responsible for implementing impact registration, compensation calculation and payment, resettlement, etc. for the Subproject. Accordingly, township LA and HD management offices have also been established.

In June 2016, the Ning'er County Subproject Leading Group was established.

In July 2016, the Jiangcheng County LA and HD Management Office was established, responsible for LA and HD work (see Appendix 9).




Figure 2-1 Organizational Chart

2.2 Staffing and Equipment

In order to facilitate resettlement, the resettlement agencies at different levels have been sufficiently staffed and created unobstructed information flows. These agencies are composed of administrative staff and technicians, with workforces of 3-33. All staff members have certain professional and administrative competencies, and experience in resettlement. See Table 2-1.

In addition, the resettlement agencies at different levels have fixed offices, sufficient funds, and basic office, transport and communication equipment, including desks and chairs, PCs, printers, telephones, facsimile machines and vehicles. The powerful organizational structure ensures the successful implementation of LA and HD.

In order to strengthen the understanding of ADB's resettlement policy among the staff of the

resettlement agencies, the Pu'er PMO invited ADB resettlement officials to offer relevant training in April 2016, covering domestic resettlement and social policies, resettlement planning, implementation, management and monitoring, etc.

2.3 Evaluation

The task force investigated the operation of the resettlement agencies. The investigation shows that relevant agencies have been established and staffed at the municipal level, and in Ning'er and Jiangcheng Counties.

The Pu'er PMO invited ADB resettlement officials to offer relevant training in April 2016, strengthening the understanding of ADB's resettlement requirements. However, there are still some deficiencies in policy understanding and resettlement practices, such as inadequate internal reporting, information compilation, etc. In addition, since the Subproject involves complex issues in compensation and resettlement, etc., the subproject staff must have sufficient capacity to implement it properly.

In this report period, the organizational setup and staffing for resettlement remained relatively stable, and it is noteworthy that a subproject leading group was established in Jiangcheng County. However, there was no substantial progress in capacity building. In particular, no capacity training was offered for the new resettlement staff in Jiangcheng County, which is adverse to capacity building and resettlement implementation. Therefore, further attention should be paid to this.

In view of this, the task force suggests that the resettlement agencies should further strengthen institutional capacity building to ensure that resettlement is implemented successfully according to the RP approved by ADB, including: 1) offering training to the new resettlement staff in Jiangcheng County as soon as possible, and strengthening policy guidance and learning; 2) keeping the staff of the resettlement agencies stable; 3) strengthening training for their staff involved in LA, HD and resettlement pursuant to the training program under the RP; 4) improving internal management systems, including file, information and fund management; and 4) in particular, regulating file management in resettlement implementation, including hardcopies and electronic files.

3 M&E of Resettlement Implementation

3.1 Construction Progress

The Subproject is divided into 10 roadbed packages (NJL-Sub1~NJL-Sub10) and 3 pavement packages (NJL-Pav1~NJL-Pav3), where NJL-Sub6~NJL-Sub10 are fully financed by the government. Ning'er County involves 7 contract packages (NJL-Sub1~NJL-Sub7), with a full length of 130.92km, including the Ning'er Town segment K0+000~K33+000, Mengxian Town segment K33+000~K81+000 and Liming Xiang segment K81+000~K130+915. Jiangcheng County involves 4 contract packages (NJL-Sub7~NJL-Sub10), with a full length of 103.15km, including the Baozang Xiang segment K130+915~K155+900, Menglie Town segment K155+900~K217+941, Qushui Xiang segment K217+941~K234+069.52.

As of December 31, 2016, bidding for all the 10 roadbed packages had been completed, and all contracts entered into. Bidding for the 3 pavement packages will be conducted in Q1 2017, and construction will begin in Q4 2017. See Table 3-1.

3.2 Land Approval

In October 2012, the Yunnan Provincial Land and Resources Department approved the construction land for the Subproject.

3.3 Resettlement Implementation

In June 2016, the Ning'er County Government issued the LA announcement of the Subproject, and the LA and HD program successively in the affected townships and villages, improving public awareness and participation level.

3.3.1 Acquisition of Collective Land

According to the updated RP, 6,101.9 mu of rural collective land will be acquired, affecting 3,066 households with 11,915 persons.

In this report period, 6,215.818 mu of collective land was acquired, including 3,225.03 mu in Ning'er County and 2,986.984 mu in Jiangcheng County. As of December 31, 2016, 6,215.818 mu of land had been acquired, accounting for 101.8% of the plan.

3.3.2 HD

According to the updated RP, residential houses of 40,131.38 m² in will be demolished, affecting 324 households with 1,242 persons.

By this M&E, the house demolition and relocation was not started yet.

3.3.3 Temporary Land Occupation

According to the RP, quarries, sandpits, mixing stations, dump sites, living and production facilities, and temporary construction roads will occupy land temporarily. Temporary land occupation will be coordinated by the highway construction headquarters.

As of December 31, 2016, though construction had begun and temporary land occupation had occurred, statistics were still unavailable.

3.4 Resettlement Policies and Compensation Rates

In June 2016, the Ning'er County Government issued the LA and HD program to Ning'er Town, Mengxian Town and Liming Xiang, disclosing the relevant compensation rates. As of December 31, 2016, compensation rates had not been disclosed in Jiangcheng County.

A LA compensation announcement has been released in Jiangcheng County (*see Appendix* **10**).

3.4.1 Policies and Compensation Rates of Ning'er County

LA for the Subproject is compensated for based on the Land Administration Law of the PRC, Regulations on the Implementation of the Land Administration Law of the PRC, Land Administration Regulations of Yunnan Province, and the LA and HD program of the Subproject.

1) Permanent LA

The compensation rates for permanent LA are set out in Table 3-5. In addition, the young crop compensation rates for irrigated and non-irrigated land area 1,500 yuan/mu and 1,000 yuan/mu respectively. Compared to the RP, the compensation rate for irrigated land in Xinping, Taida and Xishitou Villages, Ning'er Town has risen from 60,000 yuan/mu to 80,000 yuan/mu; in Qianle, Anning, Xuande and Yalu Villages, Mengxian Town, and Xianren and Tuanshan Villages, Liming Xiang, the compensation rate for irrigated land has risen from 30,000 yuan/mu to 40,000 yuan/mu and that for non-irrigated land has risen from 20,000 yuan/mu to 25,000 yuan/mu. Therefore, the LA compensation rates comply with the RP, and some rates are higher.

5) Tomb relocation

The compensation rate for relocated tombs is 8,000 yuan per earth tomb or 12,000 yuan per brick/stone tomb.

In addition, compensation rates for other special facilities will be based on industrial technical standards.

2) HD

The HD compensation rates are 1,720yuan/m² for frame structure, 1,440 yuan/m² for masonry concrete structure, 730yuan/m² for brick and timber structure, 390 yuan/m² for earth timber structure and 240 yuan/m² for simple structure.

In addition, the households affected by HD will receive subsidies under poverty reduction for non-local relocation³.

3.5 Funds and Disbursement

3.5.1 Disbursement Progress

As of December 31, 2016, resettlement funds of 76.907 million yuan had been disbursed, including 63.605 million yuan in Ning'er County and 13.301 million yuan in Jiangcheng County.

3.5.2 Disbursement Process




Figure 3-1 Fund Disbursement Flowchart

All LA and resettlement funds are raised by PMG, and managed by PTIG. As resettlement agencies, the county governments ensure that all required resettlement funds are available timely and fully. See Figure 3-1.

3.6 Evaluation

Through field investigation, interviews, FGDs and literature review, the task force thinks that as of December 31, 2016, the resettlement work of the Subproject was in orderly progress, and LA and HD compensation fees had been disbursed to the AHs. In this report period, the task force received no appeal. However, the progress of house demolition is relatively slow in general. Given the house reconstruction would take times, the demolition and relocation of house should be accelerated.

4 Public Participation and Grievance Redress

4.1 Public Participation

At all stages of the Subproject, the Pu'er PMO and the IA attach great importance to public participation and consultation, collect comments from government agencies, affected enterprises and APs extensively, and encourage all stakeholders to take an active part in the Subproject.

4.1.1 Preparation Stage

At the preparation stage, the Pu'er PMO, Pu'er Transport Investment (Group) Co., Ltd. (PTIG), IA, township governments, and RP preparation agency carried out various public participation activities, such as community mobilization and publicity, social survey, planning, which promoted local residents' awareness of the Subproject, compensation rates and resettlement policies.

4.1.2 Implementation Stage

At the implementation stage, PMG, PTIG, the resettlement agencies, etc. conducted extensive public participation and consultation, including announcement posting, mobilization meeting, RIB distribution, etc.

1) Public meetings

In June-July 2015, public meetings were held in the affected villages to explain the relevant policies, regulations and compensation rates, and further discuss resettlement measures.

2) **RIB distribution**

In order that the APs and local governments are fully aware of the compensation rates and the RP, the resettlement agencies distributed to the RIB to the villages and households affected in August 2015, covering the state laws and regulations on resettlement, compensation rates, entitlements, policies, etc.

3) Posting of LA announcement and DMS result disclosure

In June 2016, the Ning'er County Government issued the LA announcement of the Subproject, and the LA and HD program successively in the affected townships and villages to ensure information openness and transparency.

In August 2016, the Menglie Town Government disclosed the DMS results to ensure that the AHs were aware of LA impacts, and affected young crops and attachments.




Figure 4-2DMS Result Disclosure in Menglie Town

4.2 Grievance Redress

A transparent and effective grievance redress mechanism has been established during resettlement implementation, as detailed below:

Stage 1

If any AP is dissatisfied with the RP, he/she may file an oral or written appeal with the village committee, township government or county resettlement office, which should make a disposition and keep written records within two weeks.

Stage 2

If the AP is dissatisfied with the disposition of Stage 1, he/she may file an appeal with the county PMO after receiving such disposition, which should make a disposition within two weeks.

Stage 3

If the AP is dissatisfied with the disposition of Stage 2, he/she may file an appeal with the Pu'er PMO after receiving such disposition, which should make a disposition within two weeks.

Stage 4

If the AP is still dissatisfied with the disposition of Stage 3, he/she may file an appeal with the competent authorities level by level in accordance with the Administrative Procedure Law.

At any stage, an AP may bring a suit in a civil court directly if he/she is dissatisfied with the grievance redress procedure or disposition.

All grievances, oral or written, will be reported to ADB in internal and external resettlement monitoring reports.

If any AP may also file an appeal with the Office of the Special Facilitator or Compliance Review Panel of ADB in accordance with ADB's accountability mechanism.

All agencies will accept grievances and appeals from the APs for free, and costs so reasonably incurred will be disbursed from contingencies. During the whole construction period of the Subproject, these appeal procedures will remain effective to ensure that the APs can use them to address relevant issues. The above grievance redress mechanism will be communicated to the APs at a meeting or through the RIB.

4.3 Evaluation

It is learned that project information is well disclosed, and the level of public participation is high. Some concerns the APs have been addressed properly by village collectives. The Pu'er PMO has not received any grievance.

The task force thinks that the adequate public participation and grievance redress mechanisms of the Subproject played a great role during resettlement. During resettlement implementation, the PMO and resettlement agencies should collect and handle grievances and appeals timely and

properly.

5 Findings and Suggestions

5.1 Key Findings

1) Project and resettlement implementation progress

As of December 31, 2016, roadbed construction had begun under a number of contracts, and temporary land occupation had occurred, but statistics were still unavailable; Compared to LA, the progress of house demolition and relocation is slow; LA compensation fees were disbursed to the AHs timely, but statistics should be strengthened.

2) Organizational structure

PTIG has established the Ning'er–Jiangcheng–Longfu Highway Construction Headquarters as instructed by PMG, responsible for the construction, quality, progress and safety management of the Ning'er–Jiangcheng–Longfu Highway, and the coordination of LA, HD and preparation with the Ning'er and Jiangcheng County Governments. In April 2016, the Pu'er PMO invited ADB resettlement officials to offer training on ADB's involuntary resettlement policy and requirements.

In support of the work of the Ningjiang Highway Construction Headquarters, the Ning'er and Jiangcheng County Governments have established LA and HD management offices, responsible for LA, HD and resettlement within their jurisdictions.

3) Information disclosure and public participation

Most of the respondents are aware of the Subproject, and 100% of them support the Subproject and expect the Subproject to be implemented as soon as possible. The IA has disclosed project information timely and fully to the public by means of Internet, FGD and village meeting. The public participation mechanism is sound and the RIB has been distributed.

4) Grievance redress

A transparent and effective grievance redress mechanism has been established during resettlement implementation. The APs may file appeals with the Pu'er PMO, the county or township government, and village committee, or bring a suit in the people's court.

The grievance redress channel is smooth, and the APs know how to file an appeal when their rights are infringed on.

5.2 Suggestions

1) Organizational structure

The resettlement agencies should further strengthen institutional capacity building to ensure that resettlement is implemented successfully according to the RP approved by ADB, including: 1) keeping the staff of the resettlement agencies stable; 2) developing a training program according to the RP to strengthen training for the resettlement staff; and 3) strengthening communication among the resettlement agencies, and improving internal management systems, including file, information and fund management (e.g., developing uniform LA, HD and disbursement formats for proper information recording and management).

2) temporary land occupation, house demolition and relocation

As of December 31, 2016, roadbed construction had begun. Statistics on temporary land occupation should be prepared as soon as possible to ensure that the AHs receive compensation timely and the temporarily occupied land is restored timely after the completion of construction. Meanwhile, the house demolition and relocation should be accelerated to ensure timely relocation of AHs relocate, so that the project can be implemented smoothly.

3) Improving the information disclosure mechanism

In order that the APs are fully aware of the Subproject's impacts, resettlement modes,

compensation rates, appeal channels, etc., further publicity on the resettlement policies of the Subproject should be conducted.

4) Paying attention to the livelihood restoration and house reconstruction of the APs

The APs may become distressed due to the improper use of compensation fees. The resettlement agencies should establish a database of the APs (including contact information), and track their livelihood restoration and house construction regularly to ensure that the objectives of resettlement are realized.




