### Preamble

In accordance with paragraph 5.9 of the “World Bank Procurement Regulations for IPF Borrowers” (July 2016) (“Procurement Regulations”) the Bank’s Systematic Tracking and Exchanges in Procurement (STEP) system will be used to prepare, clear and update Procurement Plans and conduct all procurement transactions for the Project.

(e) Publication of contract award information – the requirement is met – PPL January 25, 2018: Articles 32; 55; 64. (f) Rights for the Bank to review procurement documentation and activities – the requirement is met – PPL January 25, 2018: (g) An effective complaints mechanism – the requirement is met – PPL January 25, 2018: (h) Maintenance of records of the Procurement Process – the requirement is met – PPL January 25, 2018.*
