## Implementation Status and Key Decisions

The Project became effective on 27 January 2016 after all legal requirements were met. The Project Implementation Manual (PIM) has been developed by UEPNDDR, and is pending finalization. The PIM includes the financial management and procurement manual. The M&E Strategy has been developed and finalized. The baseline study terms of reference were developed and are currently being reviewed by the task team. In addition, the family Livelihoods Support Strategy and its ToR have been developed and is being discussed with the task team.

The Project was officially launched on February 26 2016 by the vice minister of defense and covered all Project's activities (including fiduciary and safeguards aspects), in Kinshasa.

Below are the project's activities status:

- 1. UEPNDDR is contracting all implementing partners to provide vocational training at the CPRs.
- 2. Selection process for the recruitment of a firm to prepare the ESMF is ongoing .
- 3. In regards to vulnerable groups and psychosocial support, a support mission will take place by end of March 2016 to provide technical assistance to UEPNDDR and guidance on work plan and relevant trainings.
- 4. Support to project implementation missions held by TTL and TDRP team members between august 2015 and February 2016 lead to strengthen dialogue with government and donors community. As a result an administrative agreement has been signed with the European Union for a total of 4.8 millions Euros to support the activities of the Project through a Multi Donor Trust Fund..

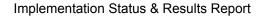

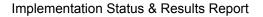
