#### Implementation Status and Key Decisions

The Project is off to a good start, and is already making progress towards meeting its initial developmental impact and financial and physical targets and milestones following project effectiveness, which was declared on August 20, 2015. The Government is very committed to the success of the Project and has agreed to put in place several measures to further improve implementation progress and widen the intended developmental impact of the Project.

A number of mitigation measures have been agreed with the Government of Malawi and PIU in areas of substantial and moderate risk including the development of Standard Operating Procedures for institutional coordination across the PIU, line departments and districts and their formalization through the Project Implementation Manual.

The PIU has, however, yet to be fully staffed and the delay in hiring additional specialists has affected project management. This will be resolved by actively recruiting additional key experts.

Moreover, the environmental and social safeguards have not yet been fully mainstreamed into project implementation, which can be partly attributed to the emergency nature of the Project and the early stages of its implementation. Moving forward, the Project will seek to screen all sub-projects and prepare appropriate instruments prior to implementation.
