Implementation Status and Key Decisions

The Project was approved by the World Bank's Board of Directors on June 19, 2015, signed on August 11, 2015, and became effective on September 4, 2015. The World Bank and the Asian Development Bank have signed a Memorandum of Understanding governing fiduciary arrangements for the co-financed portions of the Project. The Government of Australia has confirmed its cofinancing contribution.

Key steps to be taken over the short term are: (a) finalizing arrangements for the establishment and operations of the Samoa Submarine Cable Company which will implement the proposed cable system; (b) completion of the independent appraisal of SSCC; (c) completion of the Reference Interconnection Officer (RIO) and review; (d) regulatory capacity assessment for OoTR under the planned Regulatory TA; and (e) completion of recruitment procedures for project administration support. The World Bank and ADB are currently reviewing the Bid Evaluation Report for the submarine cable system.
