Implementation Status and Key Decisions

A Project Preparation Advance has been provided for the project. Total value is 1.3 Million USD. A total of 765,000 USD has been disbursed (60%) as of 21 June.

The following activities have been completed or are being implemented.

- 1. An international conference on transparency and corruption (Completed). And important outcome of the conference was the Fisheries Industry Transparency Initiative (FITI) which promotes transparency standards in the fishing industry.
- 2. Update and redesign of the mining registry (for mining exploration permits), including the installation of new software and training (Completed)
- 3. In-depth assessment and funcitonal audit of the current electronic public financial management (GFMIS) system (Ongoing). The procurement commission is current preparing the shortlist of companies. The selected company should begin working in the fall.
- 4. Assessmenf of the current institutional set up and system for land registration and land titling (Completed). A technical report was delivered in May 2016 and is being used for the design of the pilot projects on land registration, which again will inform the broader land reform process.
- 5. Support to the tax department on Base Erosion and Profit Shifting (Ongoing). An initial scoping mission with OECD tax and development advisor was organized and a work plan was developed and approved with the tax department. The technical assistance will be provided by OECD and Expertise France.
- 6. A complete report on the parastatal sector including SOEs and Autonomous Government Agencies (ongoing). A contract was signed with a Moroccan-Mauritanian consultancy firm and they have already prepared the data collection tools which have been sent to all parastatal agencies. Approximately half of the companies have responded. The report should be finalized in september/october
- 7. Assessment of the economic growth impact of the Public Investment Programme (Completed). The report is being used as an input in the Public Expenditure Review and will be discussed in more detail with the authorities.
- 8. Legal advice on harmonization of all procurement related legal texts laws, decrees, etc (Completed). The authorities now have one reference document for all procurement legislation.
- 9. Design of a national public procurement professionalization and certification scheme (Ongoing). Terms of reference have been finalized and the bank has recently given its non-objection.
