The Financing Agreement was signed on November 20, 2015. The Parliament of Kosovo ratified the Project Financing Agreement on February 24, 2016 (through the Law No. 05/L-086 on 'ratification of the Financing Agreement between the International Development Association on Project for improving Education System), and issued the Legal Opinion after the abovementioned Law was published in the Official Gazette of the Republic of Kosovo (No. 10/2016, dated March 21, 2016 and entered into force on April 5, 2016). The Ministry of Education complied with the conditions of effectiveness as specified in the Financing Agreement enabling the Bank to declare effectiveness as of May 13, 2016.
