Implementation Status and Key Decisions



The project started its implementation just over three and a half months ago: its official start date was June 9, 2015. Therefore, it can be considered to be in its initial stage of implementation. The project has made considerable progress since its inception and it is likely that it will achieve its objectives. Major contracts (three in number) linked to the procurement of crash barriers have been procured. The value of these contracts constitutes over three-fourths of the project cost. The capacity strengthening component has been making good progress as well. The World Bank has completed its first review of the project and the relevant documents linked to the review are being finalized. Currently the project has no major issues. The World Bank team has been monitoring the project progress closely, especially the activities linked to the development of legislations, regulations, awareness and skill development.
