### **B.** Project Objectives

to promote inclusive market-led agricultural growth based on targeted promotion of increased productivity, quality of agricultural output, and enhanced commercialization.

#### C. Project Description

The SAGPP is the proposed response to challenges faced by the agricultural sector in Sindh province of Pakistan. The SAGPP identifies interventions that will generate results within the given time to inform design of subsequent investment subprojects as well as support the Government in developing its Provincial Agricultural Development Strategy. The SAGPP hence takes a long-term approach, where future investments in the sector will build on the lessons from previous ones for optimum growth of the sector. The proposed SAGPP will be implemented over a period of five years and would have the following three components: (1) Investment Subprojects for Agricultural Growth; (2) Capacity Building for Provincial Agricultural Policy and Program Development; and (3) Program Coordination, Management, and Monitoring and Evaluation.

# D. Project location and salient physical characteristics relevant to the safeguard analysis (if known)

Specific activities to be supported by the project under a programmatic approach would be identified on demand, as expressed by potential beneficiaries. At this point in time, there is no defined identification of specific subprojects to be supported, but the project, and the program it would support, would be implemented province-wide in Sindh. The province has fertile irrigated agricultural lands and support wheat-rice on the right bank of the Indus river while wheat-cotton, and wheat-rice are cultivated on the left bank of the river. Sindh being located in the deltaic region has flat lands, slope on average is less than 1 ft per 1 mile and therefore drainage of irrigation return flows remains a challenge in the area. Over the recent past Sindh has also experienced heavy floods and rural population of Sindh suffered significantly due to standing floodwater. Sindh also produces fine quality fruits including mangoes, bananas and dates. Livestock rearing is also major activity in the area. Rural Sindh therefore presents agro-based environmental settings and project interventions could bring positive changes in them.

#### E. Borrowers Institutional Capacity for Safeguard Policies

Building upon the Environmental/Social Impact Assessments (ESIA) of ongoing operations, the project shall prepare an ESMF, including environment and social baseline; screening procedures for environment and social risks due to anticipated project activities; institutional capacity assessment and capacity building plan; public consultation summary; institutional procedures and mechanisms for screening and environment and social due diligence during various sub project's preparation, monitoring and supervision plan, as well as Pest management Plan and a generic ESMP (Environment and Social management Plan) for anticipated set of sub project activities.

The proposed project would be implemented by the Agriculture Department and the Livestock and Fisheries Department. The Agriculture Department is already implementing Bank financed Sindh OFWM project under its OFWM Directorate and has therefore some capacity regarding social and environmental safeguards implementation including preparation of Pest Management Plans. The Livestock and Fisheries Department will however need to be strengthened. The project would further strengthen the capacity for safeguards compliance of relevant agencies involved in implementing the proposed activities. For the proposed project activities presented as components 1, 2 and 3, which have limited and reversible environmental impacts, Environment Category B is proposed for the project.
