II. DESCRIPTION OF THE ASSOCIATED GRANT OPERATION

The objective of the project - Technical Cooperation Grant BR-T1304 (GEF project 5760) "Capacity Building and Institutional Strengthening on the National Framework for Access and Benefit Sharing (ABS) under the Nagoya Protocol" - is to develop and

implement a national legal and regulatory framework and the administrative and governance capacity to enable Brazil to fulfill the ABS provisions of the Convention on Biological Diversity and the Nagoya Protocol¹. The PIF for the operation BR-T1304 was approved and included in the GEF Work Program on May 27, 2014 to proceed for its formal preparation. The Project Preparation Grant (PPG) and its corresponding funding, has also been approved by the GEF on the same date to support the definition of the scope for each project component described in the PIF and TC abstract for BR-T1304.

The proposed TC Grant BR-T1304 will finance the following components:

- a. National Legal Framework for ABS. This component aims to support the necessary legislative, policy and regulatory measures to establish a new ABS legal framework and harmonization of regulatory framework with the Nagoya Protocol. The objective is to establish the new legal and regulatory framework for ABS by: i) supporting the ratification of the Nagoya Protocol and the enactment of a new ABS bill; ii) harmonizing National Regulations with the Nagoya Protocol; and iii) supporting key stakeholders to improve their understanding of the requirements and implications of the legal harmonization.
- b. Knowledge management and training. This component seeks to broaden the capacity of different stakeholders to fully take advantage of the opportunities ABS has to offer by focusing on (i) the capacity of Indigenous and Local Communities (ILCs) to participate in ABS; (ii) the development of web based instruments to facilitate knowledge sharing and ABS processes; and (iii) pilot implementation of ABS processes under the new framework.
- c. Monitoring and Evaluation. This component will enable the creation of results monitoring systems as well as the project's mid-term and final evaluations.

III. OBJECTIVE AND JUSTIFICATION

The proposed TC's objective is to support preparation of the full-fledged GEF project proposal by providing inputs for detailed design and validation of the components, their indicators and targets, confirmation of cofinancing, risk assessment, institutional arrangements for execution, detailed budget and other supporting documentation for the preparation of the CEO Endorsement Request for GEF and the final document for the BR-T1304 operation. The proposal will show the projects contribution to the GEF Focal Area and national sustainable development objectives and the detail the expected global environmental benefits.

The proposed TC will contribute to the following GCI-9 lending program priority targets: (i) poverty reduction and equity enhancement, as the TC will enable the GEF project create a framework for opportunities for sharing economic benefits with local providers

and associated traditional knowledge from poorer segments of the population indigenous peoples and traditional communities; and (ii) climate change, sustainable (including renewable) energy, and environmental sustainability, by strengthening Brazil's capacity for conservation and sustainable use of genetic resources provided by it rich biodiversity.

IV. DESCRIPTION OF ACTIVITIES/ COMPONENTS AND BUDGET

The proposed TC will finance consultancies and workshops to support the preparation of the full-fledged GEF operation, organized into three components aligned with the :

<u>Component 1.</u> Support the legal framework and regulatory harmonization for ABS under the Nagoya Protocol. It includes the following main activities:

- 1) Legal research and literature review, baseline definition and implementation proposal for the new ABS legal framework; assessment of legal and regulatory gaps, opportunities and barriers to fully implement the Nagoya Protocol and identification of additional requirements;
- 2) Development of a proposal for the knowledge and communication action plan and dissemination strategy including stakeholder consultations (decision makers involved in structuring the legal framework for ABS);
- 3) Institutional analysis and proposed strengthening arrangements and governance capacity of the Genetic Resources Management Board (CGEN);

<u>Component 2</u>. Knowledge management systems and capacity building

- 1) Key stakeholders analysis and mapping (traditional and indigenous communities, industry in research and technology development, institutions) identification of their roles in project implementation and the necessary tools to engage stakeholders in the decision making process;
- 2) Gathering of baseline information and knowledge gaps for ABS information, procedures and reporting system; TOR for development of tools and community protocols; administrative procedures to conduct ABS agreements;
- 3) TOR for development of proposal for a national ABS clearinghouse for information sharing and relevant instruments for use by stakeholders (providers and users of genetic resources and traditional knowledge), such as best practices and codes of conduct; proposal for an electronic web-based ABS information and management system;
- 4) Design of awareness campaigns and a human resources training strategy on ABS for traditional and indigenous communities (providers) and key potential users (research and technology development); definition of target population and priority criteria for implementation of capacity building; design of training modules for specific target groups;
- 5) Detailed design of a pilot to apply the framework for ABS through negotiating and executing ABS contracts, which will include assessment of priority areas with high potential for genetic resources; identification and engagement of potential users and providers and support ABS processing, authorization, contract and execution.

6) Development of monitoring system and impact evaluation plan.

Indicative Budget

The TC will be financed with GEF resources through a Project Preparation Grant (PPG). Its corresponding funds have been approved by the GEF on the same date as the PIF.

V. EXECUTING AGENCY AND EXECUTION STRUCTURE

The IDB will be the executing agency for this Technical Cooperation at the request of the Government of Brazil, with the INE/RND division responsible for its implementation and supervision. The Bank will be responsible for the administration of the procurement of consulting services. This arrangement has the following reasons: i) the complexity in project implementation involving different institutional jurisdictions and stakeholders; ii) Bank's support would facilitate the task ensure timely delivery of results and more speedy preparation process.

The TC procurement will follow Bank policies (documents GN-2350-9, GN-2349-9, and GN-2303-20) and will adhere to the TC procurement plan (Annex III). Individual consultants will be contracted under the rules of the Bank's human resources policy. Consulting firms will continue to be contracted according to the Bank's policies on the selection and contracting of consultants (document GN-2350-9); the contracting of non-consulting services (e.g. seminars) will observe the Bank's Corporate Procurement Policies (document GN-2303-20).

VI. PROJECT RISKS

Despite the Bank's acting as the contracting agency, the project implies involvement of a multilayered institutional structure, requiring solid capacity for coordination and collaboration with key stakeholders, as well as coordination of various consultants in

charge of the different subjects. To support the project team in averting this risk, a consultant to coordinate activities in the field will be contracted, with dedication full-time for the duration of the preparation activities, as well as close involvement by the Bank's project team in its execution.

VII. EXCEPTION TO BANK POLICY

There are no exceptions to Bank policy.

VIII. ENVIRONMENTAL AND SOCIAL CLASSIFICATION

In accordance with the Environmental and Social Compliance (OP-703) and the Safeguards Toolkit, this project is classified as category "C".
