Implementation Status and Key Decisions

BANGLADESH: Progress toward the achievement of the PDO remains moderately unsatisfactory because the national ratification of the statute for the South Asia Wildlife Enforcement Network (SAWEN) -- which will be the regional mechanism for collaboration on addressing wildlife crime and protection threats -- by each member country has not been completed. Also, implementation issues that are critical to meeting the PDO have not been fully resolved. These include: (i) the retention of the staff for the Wildlife Circle and their absorption in the revenue budget of the Government of Bangladesh; absorbing them into GOB's revenue budget; (ii) delay in the procurement of the Wildlife Center construction; (iii) lackluster implementation of Window 1 sub-projects that are implemented by the Bangladesh Forest Department's field-based divisional forest officers; and (iv) slow development of the project's monitoring and evaluation (M&E) system.

NEPAL: Implementation advanced considerably since the mid-term review in May 2014 with the elimination of the impediments faced by the project coordination unit (PCU) as a result of decisions by the management of the National Trust for Nature Conservation (NTNC) where the PCU is located. The Departments of National Parks and Wildlife Conservation and of Forests made improvements to the monitoring of sub-project activities and maintenance of investments carried out at the field level. Disbursements out of the IDA grant rose from 43% in May 2014 to 58% at present.

OVERALL: Although implementation progress is rated as satisfactory for Nepal, the considerably larger project cost and IDA credit for Bangladesh have led to a moderately unsatisfactory rating for this project (the first phase of the APL). The proposed project restructuring will be formalized to reflect the agreed changes in the results framework by the three countries participating in the APL and the modifications to the project in Bangladesh.

The first regional thematic meeting to discuss the institutional arrangements for wildlife crime control in the countries participating in the APL was hosted by the Bangladesh Forest Department (BFD) on March 10-11, 2015 in Dhaka. Participants from Bangladesh, Bhutan and Nepal attended the meeting which resulted in productive discussions on cooperation in wildlife crime control. The countries agreed on the areas for further collaboration and on convening two more thematic meetings to be hosted by BFD (human-wildlife conflict and knowledge sharing of project experiences) during the remainder of the project period.


