Implementation Status and Key Decisions

The Tanzania Education and Skills for Productive Jobs (ESPJ) Project was approved by the Board of the World Bank on June 15, 2016. The legal agreements for the Project were signed on July 26, 2016. The Ministry of Education, Science and Technology has made progress toward meeting the two effectiveness conditions of the Project: (I) approval of the National Skills Development Strategy and; (ii) adoption of the Program Implementation Plan. Due to delays external to the Program, notably approval of the National Skills Development Strategy the effectiveness deadline was extended to January 2017, but declaration of effectiveness is expected before that date.
