# Implementation Status and Key Decisions



This ISR is based on the latest official supervision mission (end of January), technical missions (Mid February and Mid March) and weekly audio and video conferences. The second supervision mission since the project became effective in February 2015 took place between January 27-29, 2016, during which the team reviewed progress in implementation and planned activities, with a focus on the next 6 months of Project execution. Implementation at the time of mission was on track overall. Since then, implementation delays have resulted from delays in budgetary allocation to Sedesol for Component 2 and some delays in the definition of the evaluation agenda for component 1 of the Project. The Bank team is monitoring the budget issue while in parallel working with Sedesol to achieve commitments and with Sedesol to expedite the work committed for this year.

Prospera Budget: The Budget for Prospera has been allocated and procurement of activities under Component 1 has started. The team expects a significant number of TA contracts to be undertaken this year and will continue to closely monitor procurement plan implementation.

Given the magnitude and complexity of the technical assistance under this Project, the team will continue to hold technical missions between official missions. The technical mission related to the integrated SIS (Sub-component 2.1.) took place in April, and a general technical mission for the rest of the components is planned for May 11-13, 2016. During the May mission one of the key topics to be discussed would be the evaluation agenda for Prospera.



#### Comments

It is important to stress that the program only expanded coverage marginally. The reason for the higher number of beneficiaries with respect to 2015 is that starting from January 1, 2016 the food support program PAL (Programa de Apoyo Alimentar) which used to be a separate program of cash transfer managed by PROSPERA with 718,000 beneficiaries is now part of PROSPERA, the only difference is that the beneficiaries are called PROSPERA beneficiaries without corresponsabilities.


