Implementation Status and Key Decisions

The overall progress of the project is very satisfactory.

The grant became effective on Sep 29, 2015 and disbursement rate is 26%.

Following a pilot phase (phase 1) of 2,500 beneficiaries in five districts, during which 172 km of roads were maintained, the project deployed in 12 additional districts (phase 2). Phase 2 is now complete and allowed 6,000 beneficiaries (240,000 men-days) to maintain an additional 480km of roads. The project is currently deploying for Phase 3 (17 new districts; 8,500 beneficiaries), with the actual start of works planned for the beginning of July. In addition, the fifth and last regional team will deploy to the Southeast in late August.
