As of January 2013, through Project implementation the following tasks have been accomplished: 100 percent of the preliminary studies and the final designs have been completed, 2014 km and 1705 km, respectively; 848 km of roads have been rehabilitated (51 percent); 2190 km have received periodic maintenance (63 percent), and 88 percent of the 24 Departmental road plans have been completed. The project is rehabilitating 41 road sections in 15 regions (Amazonas, Apurímac, Ayacucho, Cajamarca, Cusco, Huánuco,




