#### **Extension of Closing Date and Additional Financing**

# A. SUMMARY

1. This restructuring paper for *Colombia Extractives Industries Transparency Initiative Implementation*, Grant No. TF019279 proposes to further extend the Grant's closing date by 5 1/2 months. The restructuring of the Extractive Industry Transparency Initiative ("EITI") consists of: (a) an extension of the Grant's closing date until December 15, 2016. The Ministry of Mines and Energy submitted an extension request to the bank through a letter received May 2, 2016.

#### **B. PROJECT STATUS**

- 2. The grant agreement for TF010050 was signed on August 27, 2015 with a proposed closing date of December 31, 2015. The grant's initial closing date was established to coincide with the closing date of the parent EITI USAID Trust Fund (USTF) effective September 19, 2012. Performance so far has been satisfactory.
- 3. The Colombian extractive industries have expanded rapidly in recent years. In 2013, oil production reached a landmark 1million barrels/day. In 2013, the extractive industries accounted for US\$ 8 billion out of a total US\$ 16.2 billion in foreign direct investment (both at record levels), 7.7% percent of GDP and 72 percent of exports. Government revenues from the sector reached US\$ 17.5 billion, almost 20% of total government revenues. While the government was hoping for further growth, low commodity prices have already had a significant negative impact on production, government revenues and expansion plans. In addition, the mining sector continues to be affected by anti-mining sentiment. Stakeholders have identified issues such as environmental impact and illegal mining as key priorities.
- 4. The EITI is seen as good practice in building trust around contentious issues such as mining. Distribution of oil and mining revenues have also been an important source of debate. The first EITI Report has for the first time provided detailed information on these payments and transfers. Despite recent changes in the Ministry of Mines and Energy, with the appointment of a new Minister, the Government of Colombia's commitment remains strong and no changes are expected to the hosting of the EITI.
- 5. Colombia produced its first EITI Report covering fiscal year 2013 in January 2016. Dissemination of the report is ongoing, including presentations in 10 municipalities. Colombia EITI is now preparing for the second report, which will cover 2014 and 2015. The multi-stakeholder group is discussing other issues to include in future reports including social payments, environmental information and beneficial ownership.
- 6. The Task Team confirms that the requested extension of the closing date is needed in order for Colombia to fully implement its EITI work program and to become validated under the

EITI standards. Colombia needs to maintain the current EITI implementation momentum, consolidate the progress achieved, continue to build understanding of the EITI process in the country amongst stakeholders and society in general, and prepare for a validation exercise.

7. There are no outstanding audits.

# C. PROPOSED CHANGES

a. <u>Extension of Closing Date</u>. An extension of the closing date to December 15, 2016 is requested. This would provide full implementation of the EITI work program leading to Colombia's validation.
