Loan No. 3139 (SF) and Grant No. 0397 (EF): South Asia Subregional Economic Cooperation Power System Expansion Project - Amendment to Loan Agreement and Grant Agreement

- 1. We refer to the Loan Agreement dated 11 July 2014 and the Grant Agreement dated 14 November 2014 between Nepal ("Borrower") and Asian Development Bank ("ADB") for the captioned project ("Loan Agreement" and "Grant Agreement", respectively, and together, "Financing Agreements"). All capitalized terms used but not defined herein shall have the meaning given thereto in the Financing Agreements, unless the context requires otherwise.
- 2. Following an understanding with the Borrower as reflected in the ADB review mission aide memoir dated 8 May 2016, ADB approved, on 15 July 2016, changes in the Project concerning the financing plan. To give effect to the changes, ADB proposes that the Financing Agreements be amended as set out in the attachments hereto.
- 3. Save and except to the extent set out in attachments hereto, the Financing Agreements remain unchanged.
- 4. Pursuant to ADB's Public Communications Policy on disclosure and exchange of information, the amendments to the Financing Agreements will be posted on ADB's website within 2 weeks from the date that the amendments becomes effective, after removing any information that falls within the PCP exceptions as specified by the Borrower.
- 5. Please indicate the Borrower's concurrence to the amendments set out in the attachments hereto and to the terms of this letter agreement by countersigning each of the two original of this letter agreement in the space indicated below. Please retain one signed original of this letter agreement for your records and return the other to ADB. The proposed amendments shall take effect on the date of receipt by ADB of a signed original of this letter agreement.

"by an agreement dated 14 November 2014, as amended by Addendum No. 1 thereto dated 11 July 2016, between ADB and the Government of Norway ("Cofinancing Agreement"), the Government of Norway has agreed to provide, and ADB has agreed to administer, the Grant provided for herein upon the terms and conditions set out in the Cofinancing Agreement;"

Section 2.01(a) shall be deleted and replaced with the following:

"ADB agrees to make available to the Recipient a grant from the Government of Norway in the amount equivalent to approximately twenty two million Dollars (\$22,000,000), as such amount may be adjusted from time to time in accordance with subsection (b) hereinafter."

3. The Table on Allocation and Withdrawal of Grant Proceeds in the Attachment to Schedule 1 shall be deleted and replaced with the following:
