## 100.8 MW Bhesada Wind Power Project

#### A. Introduction

The project comprises of development of 100.8 MW wind power project in Jaiselmer District, Rajasthan. 48 Suzlon S-97\_120m WTGs with 97 m rotor diameter and 120 m hub height will be installed in this project. Project lies between 26°37′16.44′′ N and 71°12′36.82′′E to 26°36′51.19′′ N and 71°26′18.33′′E. wind farm will be connected to 220 kV S/S pooling station already existing at Bhesada which in turn will be connected to RRVPNL (state transmission utility) 400/220 kV Akal (Jaisalmer) grid substation (GSS) for power evacuation from the project.
