A. BACKGROUND AND OBJECTIVE

The Federal Government of Nigeria (FGN) has received a credit from the Africa Development Bank (AFDB) towards the cost for the *Ebonyi State Ring Road Project in Ebonyi State* and it intends to apply part of the proceeds for the Engagement of a Procurement Consultant for the Ebonyi State Ring Road Project.

The Ebonyi State Ring Road Project Objective is to contribute to socio-economic development, poverty reduction through improved road transport infrastructure to reduce road maintenance costs, vehicle operating cost and travel time

THE SCOPE OF THE ASSIGNMENT

The Consultant shall provide support to the project implementation unit in preparation and processing:

- i. The Project Procurement plan,
- ii. Request for Expression of Interest REOI, EOI, RFPs Tech.& Fin. Evaluation, Contract Negotiation, Award etc
- Provide hands-on training to the PIU on implementation matters covering procurement, disbursements, report writing, Conduct post-implementation review, sensitization for management staff of Ebonyi State Ministry of Works and Transport on the basic procurement
- iv. Preparation of monthly, quarterly and annual progress reports
- v. Any other responsibility relating to the project as required by the Project Coordinator
- vi. Prepare and deliver basic procurement training for the PIU, Ebonyi State Ring Road Project in particular the procurement officer on hands-on procurement principles and practices.

The Ebonyi State Ministry of Works and Transport now invites eligible Individual consultants to indicate their interest in providing the Services. Interested Consultant should submit an expression of interest and curriculum vitae demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- A degree in Procurement, Public Administration, Engineering, Law, Banking & Finance, Business Management, or any related fields; a post graduate degree in Procurement, Management, Business or Law will be considered an advantage. Membership of recognized procurement professional body is a merit.
- A minimum of Ten (10) years of direct relevant experience in public procurement, including broad expertise in the procurement of consultancy services;
- State-of-the-art knowledge of the concepts, principles and practices which govern international procurements, the Knowledge of Consultancy services contract, preparation of Terms of References, etc;
- Seasoned knowledge of all major facets of the AfDB or IsDB or World Bank procurement policies and review of Borrower's procurement documents and decisions is highly desirous;
- Training skills Proven experience in training to PIUs or public servants on basic procurement principles; and
- Mentoring skills Experience in preparation and delivery of mentoring program on procurement to PIUs or Public Staff.
