## Implementation Status and Key Decisions

The Project's operational Coordination Delegate (COD) continues to be fully operational since its installation in April 2015 and in spite of the difficult context of low capacity in the public civil services which are in the driver seat for the Project's execution, implementation is progressing smoothly. The cost of 2016 Annual Work Program & Budget is US\$.4,985,770 about GNF 44.373.327.000 equivalent. It was approved in April 2016 by the Bank together with an updated Procurement Plan. The key challenge still consists in completing the procurement processing. for the different studies and capacity building of the targeted public institutions and the Chamber of Agriculture. In order to make sure some PDO level indicators become attainable under the project, a restructuring will be proposed for some of them by the MTR to be planned by end April 2017 at the latest.





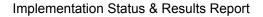


