Implementation Status and Key Decisions

The Project became effective onby March 31, 2015. The key staff of the PIU was recruited since mid- March and has started working steadily from mid-April 2015. An interim Annual Work Program & Budget (May to December 2015) and an updated Procurement Plan for 18 months were prepared by the PIU and approved by the Bank. Overall the implementation started well in spite of some delay in the procurement processing: (i) for the institutional and organizational diagnosis and (ii) for the International Assistance Firm. This delay is due to : (i) the limited capacity of the Directorate of Strategy and Development (BSD) in the Ministry of Agriculture which led the preparation of activities without making significant progress on these 2 aspects and (ii) the 3 months delay on the effectiveness which didn't allow a timely take-off for the PIU.

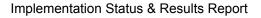




