II. Objective and Justification

2.1 The purpose of this operation is to support the Government of Guyana in strengthening the housing delivery system for the indigenous Amerindian populations. This operation conceives housing as a basic asset that will support Amerindian socio-economic development. Amerindians total approximately 9.1% of Guyana's population. They are concentrated in regions One, Seven, Eight, and Nine (the hinterland), in approximately 14% of Guyana's territory. Poverty levels are high in the hinterland, with estimated rates of 78%. Demand for housing in the hinterland is high: A study conducted among 8 hinterland communities in 2009 revealed that

approximately 74% of the population of these communities lives in inadequate and overcrowded units.¹

- 2.2 This operation will support the design of the reformulation of the Expansion and Integration of Basic Nutrition Program (GY-L1028; 2270/BL-GY) into a Sustainable Housing for the Hinterland Program. The program is expanding a hinterland pilot that was executed under the Second Low Income Settlement Program (2102/BL-GY; GY-L1019). The hinterland pilot was the first governmental intervention seeking to provide housing for the indigenous population. The methodology for its implementation has been very innovative,² and the reformulated program will build on the lessons learned to expand and systemize a housing delivery system for the Amerindian population in the hinterland. This TC will accompany the preparation of the reformulated program in supporting institutional strengthening activities for the Central Housing and Planning Authority (CH&PA) within the Ministry of Communities.
- 2.3 This TC will support the Government of Guyana efforts to: (i) strengthen the housing program for the hinterland; and (ii) foster innovative processes and methods that consider the unique geographic and cultural realities of the hinterland and Amerindian populations.

III. Description of activities and outputs

- 3.1 **Component 1. Strengthening the housing program for the hinterland**. This component will cover activities related to the identification and implementation of capacity building opportunities. Activities are: (i) identification of institutional capacity strengthening components for GY-L1028; 2270/BL-GY; and (ii) capacity building for CH&PA staff, so that the pilot can be transformed into a regular program within CH&PA portfolio.
- 3.2 **Component 2. Fostering innovative processes and methods**. This component will finance the development of new planning, monitoring, and evaluation mechanisms for the delivery of housing solutions to the hinterland. Activities are: (i) definition of a monitoring and evaluation framework for a larger housing delivery system in the hinterland; ³ (ii) promotion of partnerships and coordination mechanisms to facilitate each outcome;⁴ and (iii) design of the monitoring instrument to evaluate how the outcome indicators of a general national program of housing for the hinterland would contribute to national development goals.

² The design of the pilot was made taking into account the low population density in the hinterland (houses are 200 meters apart), the reliance of the population upon subsistence farming (half of the households lack a stable source of income), and the quality of transitory structures (the Amerindian tradition includes building expertise, supported by the presence of local material). As a result the execution of the pilot is characterized by: participatory design, self-built approach, the use of local material, and off-the-grid basic services accompanied by training. Those principles will apply to the design of the reformulated program.
