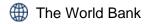

#### Implementation Status Overview

The Project continues progressing towards achievement of the Project Development Objective (PDO) as measured by two out of four PDO indicators. PDO indicator 3 (decrease in the mortality rate from cardiovascular disease) surpassed the end target (59,3 x10000/ 67.5/100000), as well as PDO indicator 4 (screening for NCD in the National Health



Insurance population), which achieved 31.12% when the end target is 30%. Data for the remaining two PDO indicators would be available by December 2014. Eight of the 16 Intermediate Indicators have already been reached, and eight are on track to be achieved. Because Project indicators are measured once a year, most indicators will be updated in March 2015.

The Project disbursed US\$18.6 million out of US\$25.3 million.

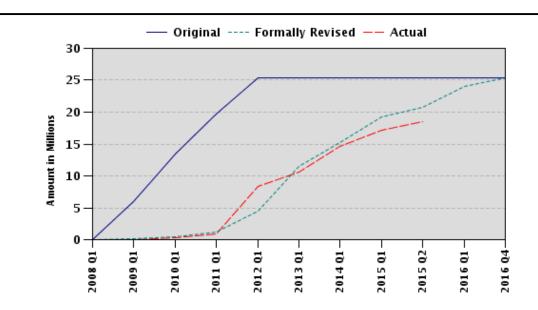
