## Implementation Status and Key Decisions

This interim ISR has been updated based on findings of the September 2015 progress report that has been issued by the Project Coordination Unit (PCU). This ISR will be updated during the next supervision and support mission which is planned from November 23-28, 2015.

- 1. The project became effective on January 29, 2015. The disbursement rate has increased from to 10.14 in June to 13.00 percent. Overall the project performance is rated as satisfactory.
- 2. The commodity-based public-private consultation platform held its first meetings in September 2015.
- 3. Eleven buyer agribusinesses are engaged with the Project of which seven have signed a partnership with the project to resource material from cooperatives (POs) up to more than 120,000 tons.
- 4. Contracts for the procurement of two sorghum processing plants for two copepratives have been signed.
- 5. The preparation of the next portfolio of 24 business plans is in progress and will complete in November 2015.
- 6. The capacity building plan for cooperatives is being implemented according to schedule.
- 7. The draft product of an agricultural insurance within the Project has been prepared by Activa Company.
- 8. The PHRD Grant in the amount of \$3.00 million is ready for signing to support mainstreaming nutrition in the Project.
