The Program was approved by the Board on April 24, 2015. The Loan Agreement was signed on July 2, 2015, and became effective on September 21, 2015. The Program will support the government in achieving a number of measurable results, targeting poor rural areas. These include improvements in maternal and child health services, as well as primary-level services addressing non-communicable diseases. Also to be supported by the Program are improvements in quality assurance and information systems. Results will be monitored and measured over the course of the coming year.
