## **Implementation Status and Key Decisions**

The credit is not yet effective. Preparing the subsidiary agreement took more time than anticipated. The effectiveness deadline was extended by 45 days to February 14, 2016. The team does not anticipate further delays. Progress towards achieving the PDO and results is fully on-track and, in some cases, ahead of schedule. The formal process to verify the achievement of prior and FY16 results that will trigger disbursements upon effectiveness is underway and fully on-track. The team will undertake a supervision mission during February 2016.
